

## A BILL TO BE ENTITLED

AN ACT REQUIRING THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO
DEVELOP AND REPORT ON STRATEGIES AND RECOMMENDATIONS FOR
IMPROVING THE DELIVERY OF MENTAL HEALTH, DEVELOPMENTAL
DISABILITIES, AND SUBSTANCE ABUSE SERVICES, AS RECOMMENDED BY
THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON HEALTH AND HUMAN
SERVICES.

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** The Department of Health and Human Services (Department) shall 10 submit a report to the Joint Legislative Oversight Committee on Health and Human Services 11 and the Fiscal Research Division by November 1, 2014, that includes all of the following 12 components:

- 13 (1) A strategy for improving communication and coordination among all
  14 divisions within the Department that administer funds or programs related to
  15 the delivery of behavioral health services, especially regarding the most
  16 appropriate and efficient uses of public and private inpatient behavioral
  17 health services. The Department shall include as part of its strategy a process
  18 to address shortages and deficiencies identified in the annual State Medical
  19 Facilities Plan.
  - (2) A plan developed in collaboration with local management entities that have been approved to operate as managed care organizations (LME/MCOs) to increase access to, and availability of, community-based outpatient crisis and emergency services for the stabilization and treatment of individuals experiencing mental health, developmental disability, or substance abuse crises in settings other than local hospital emergency departments and State-operated psychiatric hospitals.
  - (3) A plan to ensure that a comprehensive array of outpatient treatment and crisis prevention and intervention services are available and accessible to children, adolescents, and adults in every LME/MCO catchment area. The plan shall ensure that an adequate number of crisis stabilization units are available in each LME/MCO catchment area.

  34 findings and recommendations, the Department shall examine the
  advantages and disadvantages of increasing this inventory of services
