TECHNICAL CONSIDERATIONS:

**BILL SUMMARY**: House Bill 392 would require a County Department of Social Services (DSS) to conduct a criminal history check on applicants for or recipients of Temporary Assistance to Needy Family (TANF) benefits or Food and Nutrition Services (FNS) benefits. This bill would also require DSS to share information with a local law enforcement agency regarding an applicant for or recipient of TANF or FNS benefits who has an outstanding arrest warrant. Finally, House Bill 392 would require DSS to deny TANF or FNS benefits to an applicant or recipient subject to an outstanding warrant for a felony charge or for a probation parole violation.

#### **ASSUMPTIONS AND METHODOLOGY:**

Based on information obtained from the NC Department of Health and Human Services, their determination is that the existing resources (human resources) are adequate to handle the increased number of database queries associated with the proposed policy. However, the Department in the process of transitioning to a new IT system (NC FAST) which will require reconfiguration to allow for compliance with the proposed policy change.

These changes to the NC FAST system are detailed below:

#### **TECHNICAL CONSIDERATIONS:**

There is a potential impact on local Counties as a function of increased coordination with the Administrative Office of the Courts and Local Law Enforcement. The requirement of Counties to act on the information obtained through currently accessible databases, would potentially require increased staffing for County Departments of Social Services. These costs are indeterminate.

It is not possible to estimate any savings achieved through the denial of benefits to applicants for the following reasons:

- no estimates are available on the number of felons or probation/parole violators currently receiving benefits;
- actionable information unavailable: 1) database often contain outdated warrants; 2) the applicable law enforcement agency may not be interested in pursuing the warrant;
