General Assembly of North Carolina enacts: <b>SECTION 1.</b> G.S. 86A-17(b) reads as rewritten: "(b) A registered barber whose certificate of registration has expired may have the ificate restored immediately upon paying all lapsed renewal fees and the required late for furnishing a health certificate if required by the Board. Where a registered barber ificate of registration has expired for a period greater than six months, the Board mators ose civil penalties pursuant to G.S. 86A-27A registered barber whose certificate h ired for a period of five years shall be required to take the clinical examination prescribes the State Board of Barber Examiners and otherwise comply with the provisions of the puter before engaging in the practice of barbering.
