

Sponsors: Referred to: A BILL TO BE ENTITLED AN ACT TO ESTABLISH A LEGISLATIVE COMMISSION TO STUDY THE CURRENT ADMINISTRATION OF HIGH SCHOOL ATHLETICS BY THE NORTH CAROLINA HIGH SCHOOL ATHLETIC ASSOCIATION. The General Assembly of North Carolina enacts: **SECTION 1.** Establishment. – There is established a Legislative Commission to Study the Current Administration of High School Athletics by the North Carolina High School Athletic Association (NCHSAA). **SECTION 2.** Membership. – The Commission shall be composed of 12 members as follows: (1) Six members appointed by the President Pro Tempore of the Senate, to include: a. A representative of the North Carolina Department of Public Instruction. A person recommended by NCHSAA. b. A high school athletic coach or athletic director. c. d. A representative of the Matthew Gfeller Sport-Related Traumatic Brain Injury Research Center at The University of North Carolina. A representative of the North Carolina Athletic Trainers Association. e. A parent of a high school student athlete whose school is placed by f. NCHSAA in the same classification as member schools with fifty percent (50%) or more students. Six members appointed by the Speaker of the House of Representatives, to (2) include:



A representative of North Carolina's school district superintendents.

A principal of a high school (i) that is classified 1A or 2A by

NCHSAA and (ii) that is in the same classification as member

A principal of a high school (i) that is classified 3A or 4A by

NCHSAA and (ii) that is in the same classification as member



A person recommended by NCHSAA.

A physician specializing in sports medicine.

The Speaker of the House of Representatives shall designate one member as cochair, and the President Pro Tempore of the Senate shall designate one member as cochair. The Commission shall meet upon the call of the chairs. A quorum of the Commission shall be seven members. Any vacancy on the Commission shall be filled by the appointing authority.

SECTION 3. Duties. – The Commission shall study the following matters related to North Carolina's high school competitive athletic activities:

- (1) The adequacy of the current conference classification system under which schools that have access to athletes from other North Carolina counties and even other states compete with schools whose student athletes must reside in a single school attendance area, and whether the classification system should apply a multiplier to the number of students at schools with greater access to athletes to place them in a higher classification.
- (2) Formulation of a playoff system that caps the student population of schools in the smallest conference at 400 students to ensure that the number of students in the schools of each conference, except for the largest one and smallest one, varies no more than thirty-five percent (35%).
- (3) The need to classify schools into up to eight classifications to ensure safety and competitive balance.
- (4) The need to minimize the number of split-classification conferences.
- (5) The current appeals process for schools to challenge classification and conference assignments, and whether schools should be permitted to appeal their placement at all steps of the process, including its finalization.
- (6) Safety issues for student athletes from a high school with a small student population playing in the same conference as a high school with a large student population because of the limited pool of players, including:
 - a. Reduced rest time for students during play.
 - b. Injuries from contact sports when students are matched incompatibly with opposing players.
- (7) Alternative methods of classifying schools and assigning those schools to conferences to improve statewide student participation and safety in competitive athletic activities.
- (8) Means to improve officiating, including (i) increased flexibility among member schools to select officials from more than one association based on availability, geographic proximity, and preference and (ii) an opportunity for schools to evaluate and rate the performance of officials.
- (9) The ability of participating schools to change the procedures governing high school athletics, and whether the current requirement that seventy-five percent (75%) of all members vote for a change is appropriate.
- (10) The need to amend G.S. 115C-12(23), which is the General Statute that controls the relationship between the North Carolina State Board of Education and the organization it designates to apply and enforce State rules governing participation in interscholastic athletic activities at the high school level.

SECTION 4. Compensation; Administration. – Members of the Commission shall receive subsistence and travel allowances at the rates set forth in G.S. 120-3.1, 138-5, or 138-6, as appropriate. With the prior approval of the Legislative Services Task Force, the Legislative Services Officer shall assign professional and clerical staff to assist in the work of the Commission. With the prior approval of the Legislative Services Commission, the Commission may hold its meetings in the State Legislative Building or the Legislative Office Building. The Commission may also meet at various locations around the State in order to promote greater public participation in its deliberations. The Commission, while in the discharge of its official

duties, may exercise all the powers provided under the provisions of G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4, including the power to request all officers, agents, agencies, and departments of the State to provide any information, data, or documents within their possession, ascertainable from their records or otherwise available to them, and the power to subpoena witnesses.

SECTION 5. Report. – The Commission shall make a final report of its findings

SECTION 6. This act is effective when it becomes law.
