

2	AN ACT REQUESTING THE JOINT COMMITTEE ON THE LIBRARY OF CONGRESS		
3	TO APPROVE THE REPLACEMENT OF THE STATUE OF CHARLES BRANTLE		
4	AYCOCK IN NATIONAL STATUARY HALL WITH A STATUE OF THE REVEREND		
5	WILLIAM FRANKLIN "BILLY" GRAHAM, JR.		
6	Whereas, in 1864, Congress established National Statuary Hall in the Old Hall of		
7	the House of Representatives in the United States Capitol, and authorized each state to		
8	contribute to the Hall two statues that represent important historical figures of each state; and		
9	Whereas, North Carolina currently has statues on display in the National Statuary		
10	Hall Collection of former governors Zebulon Vance and Charles Brantley Aycock given by the		
11	State in 1916 and 1932, respectively; and		
12	Whereas, in 2000, Congress enacted legislation authorizing states the ability to		
13	request that the Joint Committee on the Library of Congress approve the replacement of a		
14	statue the state had provided for display in Statuary Hall; and		
15	Whereas, William Franklin "Billy" Graham, Jr., was born on November 7, 1918, to		
16	William Franklin Graham and Morrow Coffey Graham, and was reared on a dairy farm in		
17	Charlotte, North Carolina; and		
18	Whereas, Billy Graham attended the Florida Bible Institute from 1937 to 1940,		
19	graduating in 1940, and was ordained to the ministry in 1939; and		
20	Whereas, Billy Graham served as pastor of The Village Church in Western Springs,		
21	Illinois, from 1943 to 1945; as a member of Youth for Christ International, where he ministered		
22	to young people and military personnel from 1945 to 1950; and as President of Northwestern		
23	Schools, a liberal arts college, Bible school, and theological seminary, from 1947 to 1952; and		
24	Whereas, after World War II, Reverend Graham preached throughout the United		
25	States and Europe and attained international prominence as an evangelist through a series of		
26	crusades that began in 1949; and		
27	Whereas, since 1950, Reverend Graham has conducted his ministry through the Billy Craham Eveneralistic Association (BCEA), machine multitudes of nearly hy means of a		
28	Billy Graham Evangelistic Association (BGEA), reaching multitudes of people by means of a		
29 30	weekly radio program, "Hour of Decision"; a newspaper column, "My Answer"; televised		
30 31	crusades; articles published in "Decision" magazine; and evangelistic films produced and distributed by World Wide Pictures and now reaching millions through the BGEA Web site and		
32	the Billy Graham Library in Charlotte; and		
32 33	Whereas, over the years, Reverend Graham has preached to live audiences of nearly		
33 34	215 million people in more than 185 countries and territories, and has preached to an estimated		
J <del>4</del>	215 minor people in more than 165 countries and territories, and has preached to an estimated		

35 2.2 billion people through television and technology; and

1 Whereas, Reverend Graham has been a renowned humanitarian and philanthropist, 2 providing financial assistance to victims of disasters, as well as collecting and distributing 3 clothing to those in need all around the world over the years; and 4 Whereas, Reverend Graham has counseled 12 presidents and has participated in 5 nine presidential inaugurations; and 6 Whereas, Reverend Graham has also counseled world leaders and has participated 7 in many historic occasions, and has been called upon as the "nation's pastor" during times of 8 national crisis. He spoke at the National Cathedral service in Washington, D.C., three days after 9 the 9/11 attack in 2001, as the nation and world watched and listened. Five presidents, 10 including George W. Bush, Bill Clinton, George H.W. Bush, Jimmy Carter, and Gerald Ford, 11 and their wives were in the audience; and 12 Whereas, in 2012, Reverend Graham was listed on the "The Ten Most Admired 13 Men in the World List" for the 56th time. He was first selected in 1955. According to the latest 14 list, Reverend Graham was tied as Number 3 with Mitt Romney, George W. Bush, and Pope 15 Benedict XVI behind President Barack Obama and Nelson Mandela; and 16 Whereas, admired and beloved by both Christians and non-Christians, Reverend 17 Graham continues to inspire the world with his good works; and 18 Whereas, there have been many great North Carolinians, but few have impacted the 19 world more than Billy Graham; and 20 Whereas, it is appropriate to honor Reverend Graham's life and works by placing his 21 likeness in the National Statuary Hall Collection for display in the United States Capitol; Now, 22 therefore, 23 The General Assembly of North Carolina enacts: 24 **SECTION 1.** The General Assembly requests that the Joint Committee on the 25 Library of Congress approve the replacement of the statue of Charles Brantley Aycock in the 26 National Statuary Hall Collection currently on display in the United States Capitol with a statue of the Reverend William Franklin "Billy" Graham, Jr. 27 28 SECTION 2. The General Assembly requests that the Honorable Pat McCrory, 29 Governor of the State of North Carolina, extend to the Joint Committee on the Library of 30 Congress his approval of the General Assembly's request to replace the statue of Charles 31 Brantley Aycock in the National Statuary Hall Collection currently on display in the United 32 States Capitol with a statue of the Reverend Franklin "Billy" Graham, Jr. 33 SECTION 3.(a) There is created the Statuary Hall Selection Committee (the 34 "Committee"). 35 SECTION 3.(b) Membership. - The Committee shall be composed of seven 36 members, as follows: 37 (1)Four members appointed by the President Pro Tempore of the Senate, one of 38 whom shall be a representative of the Billy Graham Evangelistic 39 Association, or the Association's designee. Three members appointed by the Speaker of the House of Representatives. 40 (2)41 **SECTION 3.(c)** Terms; Chairs; Vacancies; Quorum. – Members shall serve terms 42 of four years. The Committee shall have two cochairs, one designated by the President Pro 43 Tempore of the Senate and one designated by the Speaker of the House of Representatives, 44 from among their appointees. The Committee shall meet upon the call of the cochairs. 45 Vacancies shall be filled by the appointing authority. A quorum of the Committee shall be a 46 majority of the members. 47 **SECTION 3.(d)** Duties. – The Committee shall do the following: 48 Select a sculptor to create a statue of the Reverend Franklin "Billy" Graham, (1)49 Jr., to be placed in the National Statuary Hall Collection and review and 50 approve the plans for the statue.

3	<b>SECTION 3.(e)</b> Compensation; Administration. – Members of the Committee shall				
4	receive subsistence and travel allowances at the rates set forth in G.S. 120-3.1, 138-5, or 138-6,				
5	as appropriate. The Committee may contract for consultants or hire employees in accordance				
6	with G.S. 120-32.02. The Legislative Services Commission, through the Legislative Services				
7	Officer, shall assign professional staff to assist the Committee in its work. Upon the direction				
8	of the Legislative Services Commission, the Directors of Legislative Assistants of the Senate				
9	and of the House of Representatives shall assign clerical staff to the Committee. The expenses				
0	1	for clerical employees shall be borne by the Committee.			
1		<b>SECTION 3.(f)</b> Reports; Termination. – The Committee shall make an interim			
22	report to the 2016 Regular Session of the 2015 General Assembly, and an annual report				
3	thereafter until the Committee has completed the duties set out in subsection (d) of this section,
