14	SECTION 1. The General Assembly finds that smart grid and smart meter					
15	technologies have the potential to provide substantial benefits to customers, including reduced					
16	electricity costs, increased energy efficiency, and increased reliability of the electric grid. The

18	may give electric utilities and customers access to more detailed electricity usage data than that					
19	collected by conventional grid and meter technologies.					
20	SECTION 2. Article 17 of Chapter 62 of the General Statutes is amended by					
21	adding a new section to read:

23	(a) <u>Title and Purpose. – This act shall be known and may be cited as the "Electric</u>					
24	Usage Data Freedom Act". The purpose of the Electric Usage Data Freedom Act is to establish					
25	standards to govern the access to and use of electricity usage data by electric utilities,

27 28	(b) <u>Definitions. – The following definitions apply in this section:</u>					
28 29	(1) <u>Aggregate electric usage data. – Electric usage data from which all</u> identifying information has been removed such that the electric usage data of

2			written or electronic request provide aggregate electric usage data to third		
3			parties.		
4		(2)	Subject to subdivision (3) of this subsection, an electric utility may make		
5			aggregate electric usage data available to the general public to promote		
6			energy efficiency and research.		
7		<u>(3)</u>	Aggregate electric usage data shall contain a sufficient number of similarly
