16	(7) Front clearance lamps and those marker lamps and reflectors mounted on the
17	front or on the side near the front of a vehicle shall display or reflect an
18	amber color.
19	(8) Rear clearance lamps and those marker lamps and reflectors mounted on the
20	rear or on the sides near the rear of a vehicle shall display or reflect a red
21	color.
22	(9) Brake lightsStop lamps (and/or brake reflectors) on the rear of a motor
23	vehicle shall <del>have red lenses<u>be</u> constructed</del> so that the light
24	displayedemitted, reflected, or displayed is red.red, except that a motor
25	vehicle originally manufactured with amber stop lamps may emit, reflect, or
26	display an amber light. The light illuminating the license plate shall be
27	white. All other lights shall be white, amber, yellow, clear or red.
28	(10) On every trailer and semitrailer which is 30 feet or more in length and has a
29	gross weight of 4,000 pounds or more, one combination marker lamp
30	showing amber and mounted on the bottom side rail at or near the center of
31	each side of the trailer."
32	<b>SECTION 3.</b> This act is effective when it becomes law.
