A BILL TO BE ENTITLED

AN ACT TO MAINTAIN ADMINISTRATION FOR CURRENT GRANT RECIPIENTS OF
THE EXISTING TRANSFORMING PRINCIPAL PREP PROGRAM AND PHASE IN
ADMINISTRATION BY THE NEW PRINCIPAL FELLOWS AND TP3 COMMISSION.

The General Assembly of North Carolina enacts:

SECTION 1.(a) Effective June 30, 2019, subsections (a) through (d) of Section 2 of
S.L. 2018-145 are repealed.

SECTION 1.(b) Section 2(f) of S.L. 2018-145 reads as rewritten:

"**SECTION 2.(f)** Notwithstanding any provision of Part 4 of Article 23 of Chapter 116 of
the General Statutes to the contrary, the nonprofit corporation contracting with the State
Education Assistance Authority pursuant to G.S. 116-209.71, as of the date this act becomes law,
shall not enter into or execute any new contracts, including the award of any new grants,
associated with grants or award a grant renewal for the Transforming Principal Preparation Grant
Program on or after the date this act becomes law."

SECTION 1.(c) Section 2(g) of S.L. 2018-145 reads as rewritten:

"**SECTION 2.(g)** As soon as practicable, but no later than June 30, 2019, For grantees
selected for grants prior to January 1, 2019, through the Transforming Principal Preparation
Grant Program under G.S. 116-209.73, the nonprofit corporation contracting with the State
Education Assistance Authority pursuant to G.S. 116-209.71, as of the date this act becomes law,
G.S. 116-209.71 shall transfer to the North Carolina Principal Fellows and TP3 Commission (i)
by June 30, 2020, all of the data in its possession that was collected from grant recipients with
the term of the grant ending prior to July 1, 2020, in accordance with G.S. 116-209.73, including
any data collected during the 2018-2019-2019-2020 fiscal year-year and (ii) by June 30, 2021, all
of the data in its possession that was collected from grant recipients with the term of the grant
ending prior to July 1, 2021, in accordance with G.S. 116-209.73, including any data collected
during the 2020-2021 fiscal year."

SECTION 1.(d) Section 11.9(o) of S.L. 2015-241, as enacted by Section 10A.5 of
S.L. 2017-57 and as amended by Section 10A.4 of S.L. 2018-5, reads as rewritten:

"**SECTION 11.9.(o)** Beginning with For the 2017-2018-2017-2018, 2018-2019, and
2019-2020 fiscal year-years, of the funds appropriated for this program, the sum of four million
two hundred thousand dollars (\$4,200,000) shall be allocated each fiscal year to the State
Education Assistance Authority (Authority) to award grants to selected-recipients-recipients
selected prior to January 1, 2019, pursuant to G.S. 116-209.73."



1 For the 2020-2021 fiscal year, of the funds appropriated for this program, the sum of two
 2 million five hundred fifteen thousand ninety-eight dollars (\$2,515,098) shall be allocated to the
 3 Authority to award grants to recipients selected prior to January 1, 2019, pursuant to
 4 G.S. 116-209.73."

5 SECTION 1.(e) G.S. 116-209.70 reads as rewritten:

6 "~~§ 116-209.70. Purpose and definitions.~~**Purpose, definitions, and applicability.**

7 (a) Purpose. – The purpose of this Part is to establish the Transforming Principal
 8 Preparation Grant Program as a competitive grant program for eligible entities to elevate
 9 educators in North Carolina public schools by transforming the preparation of principals across
 10 the ~~State.~~ State and providing for forgivable scholarship loans to participants of those school
 11 leader preparation programs. The Authority shall administer this Program through a cooperative
 12 agreement with a private, nonprofit corporation to provide funds for the preparation and support
 13 of highly effective future school principals in North Carolina.

14 (a1) Administration of Forgivable Scholarship Loans. – Upon the grant recipients'
 15 selection of the program participants for the school leader preparation programs, the grantee shall
 16 transfer the names of the program participants to the Authority. The Authority shall perform all
 17 of the administrative functions necessary to implement the forgivable scholarship loans to the
 18 school leader preparation program participants, which functions shall include rule making,
 19 disseminating information, acting as a liaison with participating eligible entities, implementing
 20 forgivable loan agreements in the form of promissory notes, monitoring loan repayment through
 21 service and cash, and performing all other functions necessary for the execution, payment, and
 22 enforcement of promissory notes required under this Part.

23 (b) Definitions. – For the purposes of this Part, the following definitions apply:

24 ...

25 (5a) Public school. – An elementary or secondary school located in North Carolina
 26 that is operated by a local board of education, charter school board of
 27 directors, regional school board of directors, chancellor for a University of
 28 North Carolina laboratory school, an innovative school operator, or the United
 29 States government.

30 ...

31 (c) Applicability of Part. – The provisions of this Part shall only apply to the
 32 administration of the Transforming Principal Preparation Grant Program for grant recipients
 33 selected for the award of grants prior to January 1, 2019."

34 SECTION 1.(f) G.S. 116-209.73(c) reads as rewritten:

35 "(c) Duration of Grants. – The nonprofit corporation shall also recommend to the
 36 Authority the duration and renewal of grants to eligible entities according to the following:

37 (1) The duration of grants shall be as follows:

38 a. Grants shall be no more than five years in duration.

39 b. ~~The nonprofit corporation may recommend renewal of a grant based~~
 40 ~~on performance, including allowing the grantee to scale up or replicate~~
 41 ~~the successful program as provided in subdivision (2) of this~~
 42 ~~subsection.~~

43 (1a) The following conditions shall apply during the grant period:

44 e.a. The nonprofit shall develop a process with the Authority for early
 45 retrieval of grant funds from grant recipients due to noncompliance
 46 with grant terms, including participation in third-party evaluation
 47 activities.

48 b. Grantees shall develop ~~and enforce~~ requirements for program
 49 graduates to serve ~~a minimum of four years~~ as school-based
 50 administrators in public schools located in North Carolina.
 51 ~~Requirements are subject to the approval of~~ Grantees shall facilitate

1 the execution of promissory notes between the Authority and program
 2 participants containing the terms for forgivable scholarship loans,
 3 including requirements for forgiveness or repayment, consistent with
 4 requirements approved by the nonprofit corporation-corporation and
 5 the provisions of G.S. 116-209.76.

6 (2) ~~In evaluating performance for purposes of grant renewal and making~~
 7 ~~recommendations to the Authority, the nonprofit corporation shall consider at~~
 8 ~~least the following:~~

9 a. ~~For all grantees, the primary consideration in renewing grants shall be~~
 10 ~~the extent to which program participants improved student~~
 11 ~~achievement in eligible schools.~~

12 b. ~~Other criteria from data received in the annual report in subsection (d)~~
 13 ~~of this section may include the following:~~

20 **SECTION 1.(g)** Part 4 of Article 23 of Chapter 116 of the General Statutes is
 21 amended by adding new sections to read:

22 **"§ 116-209.75. Funds for administration.**

23 Notwithstanding any other provision of law, for the 2019-2020 and 2020-2021 fiscal years,
 24 the Authority may use up to one hundred thirty thousand dollars (\$130,000) each fiscal year from
 25 the total funds appropriated in a fiscal year for the Transforming Principal Preparation Grant
 26 Program for its administrative costs.

27 **"§ 116-209.76. Terms of forgivable scholarship loans.**

28 (a) Notes. – A program participant shall be eligible for a forgivable scholarship loan in
 29 the amount of up to twenty thousand dollars (\$20,000) per year for up to two years in the program,
 30 with a maximum loan amount of forty thousand dollars (\$40,000) per participant. All forgivable
 31 scholarship loans shall be evidenced by notes made payable to the Authority that bear interest at
 32 a rate not to exceed ten percent (10%) per year as set by the Authority and beginning 90 days
 33 after completion of the school leader preparation program, or 90 days after termination of the
 34 loan, whichever is earlier. The forgivable scholarship loan may be terminated upon the recipient's
 35 withdrawal from the preparation program or by the recipient's failure to meet the standards set
 36 by the nonprofit corporation and the grantee.

37 (b) Forgiveness Through Service. – The Authority shall forgive the total amount of a
 38 forgivable scholarship loan and any interest accrued on the loan if, within seven years after
 39 graduation from a school leader preparation program, exclusive of any authorized deferment for
 40 extenuating circumstances, the recipient serves as a school administrator at a North Carolina
 41 public school, in any combination of the following for every year of service:

42 (1) If the school administrator serves one year at a school that qualifies as a
 43 high-need school under G.S. 116-209.70(b) at the time the school
 44 administrator accepts employment at the school or, if the school administrator
 45 changes employment during this period to be employed at another high-need
 46 school, then the recipient shall have fifty percent (50%) of the total amount of
 47 the loans forgiven.

48 (2) If the school administrator serves one year at a school that does not qualify as
 49 a high-need school under G.S. 116-209.70(b), then the recipient shall have
 50 twenty-five percent (25%) of the total amount of the loans forgiven.

1 A recipient shall be eligible for a percentage of the total amount of loans forgiven under this
2 subsection regardless of whether the recipient repays all of the recipient's forgivable scholarship
3 loans through service.

4 (c) Repayment Period. – The Authority, in collaboration with the grantees, shall monitor
5 the acceptability of service repayment agreements and compliance of the recipient with the
6 agreement. A forgivable scholarship loan shall also be forgiven if the Authority finds it is
7 impossible for the recipient to work for four years as a school administrator, within seven years
8 after completion of the preparation program supported by the loan, because of the death or
9 permanent disability of the recipient. If the recipient repays the forgivable scholarship loan by
10 cash payments to the Authority, all indebtedness shall be repaid within 10 years after completion
11 of the school leader preparation program supported by the loan. If the recipient completes the
12 school leader preparation program, payment of principal and interest shall begin no later than 27
13 months after the completion of the program. Should a recipient present extenuating
14 circumstances, the Authority may extend the period to repay the forgivable scholarship loan in
15 cash to no more than a total of 12 years."

16 **SECTION 1.(h)** Notwithstanding G.S. 116-209.76, as enacted by this section,
17 eligibility for a forgivable scholarship loan under G.S. 116-209.76 shall apply beginning with
18 school leader program participants entering, on or after June 1, 2020, a school leader preparation
19 program that is supported by a grant awarded pursuant to Part 4 of Article 23 of Chapter 116 of
20 the General Statutes.

21 **SECTION 1.(i)** Effective July 1, 2021, Part 4 of Article 23 of Chapter 116 of the
22 General Statutes, as amended, is repealed.

23 **SECTION 1.(j)** Effective July 1, 2021, Section 11.9(m) of S.L. 2015-241, as
24 amended by Section 4.3 of S.L. 2016-123, Section 10A.5 of S.L. 2017-57, and Section 10A.4 of
25 S.L. 2018-5, is repealed.

26 **SECTION 1.(k)** Effective July 1, 2021, Section 11.9(o) of S.L. 2015-241, as enacted
27 by Section 10A.5 of S.L. 2017-57, and amended by Section 10A.4 of S.L. 2018-5 and subsection
28 (d) of this section, is repealed.

29 **SECTION 1.(l)** Article 5C of Chapter 116 of the General Statutes reads as rewritten:
30 "Article 5C.

31 "North Carolina Principal Fellows and Transforming Principal Preparation Program.

32 **"§ 116-74.41. North Carolina Principal Fellows and TP3 Commission established;**
33 **membership.**

34 (a) There is established the North Carolina Principal Fellows and TP3 Commission. The
35 Commission shall exercise its powers and duties independently ~~of the Board of Governors of The~~
36 ~~University of North Carolina~~ in its administration of the North Carolina Principal Fellows and
37 Transforming Principal Preparation Program, which includes the Principal Fellows Program and
38 the North Carolina Transforming Principal Preparation Program, in accordance with this Article.
39 The Director of the ~~Principal Fellows Program~~ shall staff the ~~Commission~~ Commission in
40 accordance with G.S. 116-74.49. The State Education Assistance Authority (~~SEAA~~) as created
41 in G.S. 116-203 shall be responsible for (i) implementing scholarship loan agreements,
42 monitoring, cancelling through service, collecting and otherwise enforcing the agreements for
43 the Principal Fellows Program scholarship loans established in accordance with

30 ~~Board of Governors of The University of North Carolina, State Board of Education, deans of~~

32 ~~Thereafter, all~~ All appointments for these seats to the Commission shall be for four-year terms.

33 (d) Except as otherwise provided, if a vacancy occurs in the membership, the appointing

36 Board of Governors of The University of North Carolina may complete a term on the
37 Commission after the member's appointment from the appointing board has expired.

38 (e) Commission members shall receive per diem, subsistence, and travel allowances in
39 accordance with G.S. 138-5 or G.S. 138-6, as appropriate.

40 (f) ~~The~~ The initial meeting of the Commission shall be called by the member of the Board
41 of Governors of The University of North Carolina appointed under subdivision (1) of subsection
42 (b) of this section and the director shall be appointed by the Commission at the initial meeting.
43 Thereafter, the Commission shall meet regularly, at times and places deemed necessary by the
44 chair.

46 For the purposes of this Article, the following definitions apply:

- 50 (3) Eligible entity. – A for-profit or nonprofit organization or an institution of

3 (4) High-need local school administrative unit. – A local school administrative
4 unit with the majority of its schools deemed to be high-need schools as defined
5 in subdivision (5) of this subsection.

6 (5) High-need school. – A public school that meets one or more of the following
7 criteria:

8 a. Is a school identified under Part A of Title I of the Elementary and
9 Secondary Education Act of 1965, as amended.

10 b. Is a persistently low-achieving school, as identified by the Department
11 of Public Instruction for purposes of federal accountability.

12 c. A middle school containing any of grades five through eight that feeds
13 into a high school with less than a seventy-five percent (75%)
14 four-year cohort graduation rate.

15 d. A high school with less than a seventy-five percent (75%) four-year
16 cohort graduation rate.

17 (6) North Carolina Transforming Principal Preparation Program. – The North
18 Carolina Transforming Principal Preparation Program established pursuant to
19 G.S. 116-74.44.

20 (7) Principal. – The highest administrative official in a public school building
21 with primary responsibility for the instructional leadership, talent
22 management, and organizational development of the school.

23 (8) Principal Fellows Program. – The Principal Fellows Program established
24 pursuant to G.S. 116-74.42.

25 (9) Program. – The North Carolina Principal Fellows and Transforming Principal
26 Preparation Program, which shall include the Principal Fellows Program and
27 the North Carolina Transforming Principal Preparation Program.

28 (10) Public school. – An elementary or secondary school located in North Carolina
29 that is operated by a local board of education, charter school board of
30 directors, regional school board of directors, chancellor for a University of
31 North Carolina laboratory school, an innovative school operator, or the United
32 States government.

33 (11) School leader. – An individual employed in a school leadership role, including
34 principal or assistant principal roles.

35 (12) Student achievement. – At the whole school level, after three years of leading
36 a school, consistent and methodologically sound measures of:

37 a. Student academic achievement.

38 b. Aggregated individual student academic growth.

39 c. Additional outcomes, such as high school graduation rates, the
40 percentage of students taking advanced-level coursework, or the
41 percentage of students who obtain a career-related credential through
42 a national business certification exam.

43 (13) Trust Fund. – The North Carolina Principal Fellows and TP3 Trust Fund
44 established pursuant to G.S. 116-74.41B.

45 **§ 116-74.41B. The North Carolina Principal Fellows and TP3 Trust Fund.**

46 (a) Trust Fund Established. – The North Carolina Principal Fellows and TP3 Trust Fund
47 shall be an institutional trust fund established pursuant to G.S. 116-36.1. All funds appropriated
48 to, or otherwise received by, (i) the Principal Fellows Program for scholarships and other program
49 purposes, (ii) the Program for the award of grants pursuant to G.S. 116-74.44, (iii) all funds
50 received as repayment of scholarship loans, and (iv) all interest earned on these funds shall be
51 placed in the Trust Fund.

1 **(b) Use of Monies in the Trust Fund.** – The monies in the Trust Fund may be used only
2 for the purposes set forth in this subsection, including (i) scholarship loans granted under the
3 Principal Fellows Program, administrative costs, and costs associated with program operations
4 in accordance with this Article and (ii) the award of grants pursuant to G.S. 116-74.44, with any
5 monies in the Trust Fund that are unencumbered due to a reduction in the number of scholarship
6 loans awarded under the Principal Fellows Program and from any funds appropriated for the
7 Program. The Authority may use up to two percent (2%) of the funds appropriated for the
8 Program or one hundred sixty thousand dollars (\$160,000) from the Trust Fund, whichever is
9 greater, each fiscal year for administrative costs, including recovery of funds advanced under the
10 Program, and may allocate to the Commission up to eight hundred thousand dollars (\$800,000)
11 from the Trust Fund each fiscal year for the following:

12 (1) The salary and benefits of the director and staff of the Program.

13 (2) The expenses of the Commission for the Principal Fellows Program, including
14 applicant recruitment.

15 (3) Principal Fellows Program monitoring and evaluation.

16 (4) Extracurricular enhancement activities for the Program.

17 (5) The expenses of the Commission to administer grants pursuant to
18 G.S. 116-74.44.

19 **"§ 116-74.42. Principal Fellows Program established; administration.**

20 (a) **Program.** – A Principal Fellows Program shall be administered by the North Carolina
21 Principal Fellows and TP3 Commission in collaboration with the State Education Assistance
22 Authority. The Principal Fellows Program shall provide up to a two-year scholarship loan to
23 selected recipients and shall provide extracurricular enhancement activities for recipients. The
24 North Carolina Principal Fellows and TP3 Commission shall determine selection criteria,
25 methods of selection, and shall select recipients to receive scholarship loans made under the
26 Principal Fellows Program.

27 (a1) ~~Trust Fund.~~ – ~~The Principal Fellows Trust Fund (Trust Fund) shall be an institutional~~
28 ~~trust fund established pursuant to G.S. 116-36.1. All funds appropriated to, or otherwise received~~
29 ~~by, the Principal Fellows Program for scholarships and other program purposes, all funds~~
30 ~~received as repayment of scholarship loans, and all interest earned on these funds shall be placed~~
31 ~~in the Trust Fund.~~

32 (a2) ~~Use of Monies in the Trust Fund.~~ – ~~The monies in the Trust Fund may be used only~~
33 ~~for scholarship loans granted under the Principal Fellows Program, administrative costs, and~~
34 ~~costs associated with program operations in accordance with this Article. The Authority may use~~
35 ~~up to eight hundred thousand dollars (\$800,000) from the Trust Fund each fiscal year for (i) its~~
36 ~~administrative costs, including recovery of funds advanced under the program; (ii) the salary and~~

15 **administration.**

16 (a) Established. – There is established the North Carolina Transforming Principal
17 Preparation Program as a competitive grant program for eligible entities for the purpose of
18 elevating educators in North Carolina public schools by transforming the preparation of
19 principals across the State and providing for forgivable scholarship loans to the participants of
20 those school leader preparation programs. The Authority shall administer the North Carolina
21 Transforming Principal Preparation Program in collaboration with the Commission as set forth
22 in this Article to provide funds for the preparation and support of highly effective future school
23 principals in North Carolina.

24 (b) Program Administration. – The Commission shall select grant recipients and notify
25 the Authority for the award of the grants with the Authority acting as the fiscal agent for the Trust
26 Fund with respect to grants awarded by the Commission. The Commission shall also coordinate
27 with grant recipients to provide extracurricular enhancement activities for program participants.
28 The Authority shall monitor the implementation of forgivable scholarship loans to school leader
29 preparation program participants, as authorized by this Article.

30 (c) Administration of Forgivable Scholarship Loans. – Upon the grant recipients'
31 selection of the program participants for the school leader preparation programs, the Commission
32 shall transfer the names of all program participants to the Authority. The Authority shall perform
33 all of the administrative functions necessary to implement the forgivable scholarship loans to the
34 school leader preparation program participants, which functions shall include rule making,
35 disseminating information, acting as a liaison with participating eligible entities, implementing

40 (a) Application Requirements. – Subject to the availability of funds for this purpose, the

13 d. Rigorous coursework that effectively links theory with practice
14 through the use of field experiences and problem-based learning.
15 e. Full-time paid clinical practice of at least five months and 750 hours
16 in duration in an authentic setting, including substantial leadership
17 responsibilities where candidates are evaluated on leadership skills
18 and effect on student outcomes as part of program completion.
19 f. Multiple opportunities for school leader candidates to be observed and
20 coached by program faculty and staff.
21 g. Clear expectations for and firm commitment from school leaders who
22 will oversee the clinical practice of candidates.
23 h. Evaluation of school leader candidates during and at the end of the
24 clinical practice based on the North Carolina School Executive
25 Evaluation Rubric.
26 i. A process for continuous review and program improvement based on
27 feedback from partnering local school administrative units and data
28 from program completers, including student achievement data.
29 j. Established relationship and feedback loop with affiliated local school
30 administrative units that is used to inform and improve programmatic
31 elements from year to year based on units' needs.

32 (b) Application Priority. – The Commission shall evaluate the applicants for grants by
33 giving priority to an eligible entity with a record of preparing principals demonstrating the
34 following:

- 35 (1) Improvement in student achievement.
36 (2) Placement as school leaders in eligible schools.
37 (3) A proposed focus on and, if applicable, a record of serving high-need schools,
38 high-need local school administrative units, or both.
39 (4) A detailed plan and commitment to share lessons learned and to improve the
40 capacity of other entities in reaching similar outcomes.
41 (5) A service area that is underserved by existing principal preparation programs
42 or demonstrates unmet need despite current available programs.

43 **§ 116-74.46. Recipient selection; use of grant funds; duration and conditions of grants;**
44 **reporting requirements.**

45 (a) Selection. – After evaluation of grant applications pursuant to G.S. 116-74.45, the
46 Commission shall notify the Authority of its selection of the recipients of grants for each fiscal
47 year. The Commission shall select up to eight grant recipients to be operating a school leader
48 preparation program with grant funds in any fiscal year.

49 (b) Use of Funds. – Each eligible entity that receives grant funds shall use those funds to

- 13 2. Manage talent, such as developing a high-performing team.
- 14 3. Build a positive school culture, such as building a strong school
15 culture focused on high academic achievement for all students,
16 including gifted and talented students, students with
17 disabilities, and English learners; maintaining active
18 engagement with family and community members; and
19 ensuring student safety.
- 20 4. Develop organizational practices, such as aligning staff,
21 budget, and time to the instructional priorities of the school.
- 22 b. Providing opportunities for sustained and high-quality job-embedded
23 practice in an authentic setting where candidates are responsible for
24 moving the practice and performance of a subset of teachers or for
25 school-wide performance as principal-in-planning or interim school
26 leaders.
- 27 (3) Collecting data on program implementation and program completer outcomes
28 for continuous program improvement.
- 29 (4) Covering the cost of attendance and completion for program participants for
30 the school leader preparation program from the funds received on behalf of
31 program participants through forgivable scholarship loans issued in
32 accordance with the requirements of G.S. 116-74.48.
- 33 (c) Duration and Conditions of Grants. – The Commission shall also notify the Authority
34 of its decisions on the duration and renewal of grants to eligible entities made in accordance with
35 the following:
- 36 (1) The duration of grants shall be as follows:
- 37 a. Grants shall be no more than five years and no fewer than two years
38 in duration, unless the Commission finds early termination of a grant
39 is necessary due to noncompliance with grant terms.
- 40 b. The Commission may renew a grant based on compliance with the
41 grant terms and performance, including allowing the grantee to scale

25 in all evaluation activities required by the Commission and submit an annual report to the
26 Commission with any information requested by the Commission. The recipients shall comply
27 with additional report requests made by the Commission. Whenever practicable and within a
28 reasonable amount of time, grant recipients shall also make all materials developed as part of the
29 program and with grant funds publicly available to contribute to the broader sharing of promising
30 practices. Materials shall not include personally identifiable information regarding individuals
31 involved or associated with the program, including, without limitation, applicants, participants,
32 supervisors, evaluators, faculty, and staff, without their prior written consent. The Commission
33 shall work with recipients, local school administrative units, and public schools, as needed, to
34 enable the collection, analysis, and evaluation of at least the following relevant data, within
35 necessary privacy constraints:

36 (1) Student achievement in eligible schools.

37 (2) The percentage of program completers who are placed as school leaders
38 within three years in the State.

39 (3) The percentage of program completers who are placed as school leaders
40 within three years in high-need schools in the State.

41 (4) The percentage of program completers rated proficient or above on school
42 leader evaluation and support systems.

43 (5) The percentage of program completers that are school leaders who have
44 remained employed in a North Carolina public school for two or more years
45 of initial placement.

46 **§ 116-74.47. Reports.**

47 The Commission shall provide the State Board of Education, the Authority, and the Joint
48 Legislative Education Oversight Committee with the data collected from grant recipients in
49 accordance with G.S. 116-74.46 on an annual basis.

50 **§ 116-74.48. Terms of forgivable scholarship loans for program recipients.**

1 (a) Notes. – A program participant shall be eligible for a forgivable scholarship loan in
2 the amount of up to twenty thousand dollars (\$20,000) per year for up to two years in the program,
3 with a maximum loan amount of forty thousand dollars (\$40,000) per participant. All forgivable

32 of the promissory note. A forgivable scholarship loan shall also be forgiven if the Commission
33 finds it is impossible for the recipient to work for four years as a school administrator, within
34 seven years after completion of the preparation program supported by the loan, because of the
35 death or permanent disability of the recipient. If the recipient repays the forgivable scholarship
36 loan by cash payments to the Authority, all indebtedness shall be repaid within 10 years after
37 completion of the school leader preparation program supported by the loan. If the recipient
38 completes the school leader preparation program, payment of principal and interest shall begin
39 no later than 27 months after the completion of the program. Should a recipient present
40 extenuating circumstances, the Authority may extend the period to repay the forgivable
41 scholarship loan in cash to no more than a total of 12 years.

42 **"§ 116-74.49. Staff to the Commission.**

14 dollars (\$3,006,098) in recurring funds shall instead be appropriated to the Principal Fellows and
15 TP3 Trust Fund established under G.S. 116-74.41B.

16 **SECTION 1.(bb)** Except as otherwise provided, this act is effective when it becomes
17 law.
