5	Whereas, the Fort Fisher State Historic Site is the most visited State Historic	Site; and
6	Whereas, many of Fort Fisher's visitors are school groups from New Hanove	r County;
7	groups from summer camp programs, such as the YMCA, Boys and Girls Clubs, and	nd Junior
8	ROTC; nursing homes; military groups; families; and other tourists; and	
9	Whereas, to accommodate the visitors at Fort Fisher, funds are needed to but	ild a new
10	visitor center, which will provide additional space for exhibits, a larger auditorium	to handle
11	several school groups at once, a multipurpose space for classrooms, storage facilities for	archives,
12	and rental space for additional income; and	
13	Whereas, funds are also needed to expand Fort Fisher's earthworks exhibit	, upgrade
14	its parking lot, and build a new maintenance facility; and	
15	Whereas, additional funds are needed to plan facilities for the Un	ıderwater
16	Archaeology Branch to be located on the grounds of the Fort Fisher State Historic Site to	preserve
17	the State's maritime history; and	
18	Whereas, funding for the last installment of eight million dollars for the 2	019-2021
19	fiscal year was included in the State's budget for the 2019-2021 fiscal biennium; how	vever, the
20	State's budget was vetoed, the funds were not received by the Department of Natural and	
21	Resources, Office of Archives and History, and the projects could not proceed; and	
22	Whereas, because of the delay, the cost of various capital projects at the Fe	ort Fisher
23	State Historic Site has increased; Now, therefore,	
24	The General Assembly of North Carolina enacts:	
25	SECTION 1. There is appropriated from the General Fund to the Depa	rtment of
26	Natural and Cultural Resources, Office of Archives and History, the sum of nine mi	llion five
27	hundred thousand dollars (\$9,500,000) in nonrecurring funds for the 2021-2022 fisca	al year to
28	complete various capital projects at the Fort Fisher State Historic Site.	•
29	SECTION 2. There is appropriated from the General Fund to the Depa	rtment of
30	Natural and Cultural Resources, Division of Historical Resources, Office of State Arcl	naeology,
31	the sum of five hundred thousand dollars (\$500,000) in nonrecurring funds for the 20	
32	fiscal year to plan facilities for the Underwater Archaeology Branch to be located on the	
33	of the Fort Fisher State Historic Site.	-
