shall be promptly made to the Airport Authority as provided in Section 2 of S.L. 2022-34, as

- amended by this act, and, after establishing the staggered terms, all terms of office shall be for three years as provided in Section 2 of S.L. 2022-34, as amended by this act. If an appointing authority fails to make an initial appointment under subdivisions (1) through (3) of Section 2 of S.L. 2022-34, as amended by this act, by October 31, 2023, and the number of vacancies on the board is such that a quorum of the board cannot be obtained, the Clerk of Superior Court of Beaufort County shall fill that vacancy upon the request of a member of the Airport Authority. To implement staggering of the terms, the following shall apply:
 - (1) The member appointed by the City of Washington shall serve a two-year term.
 - One of the members appointed by the Beaufort County Commissioners shall serve a two-year term. One of the members appointed by the Beaufort County Commissioners shall serve a three-year term. One of the members appointed by Beaufort County Commissioners shall serve a four-year term.
 - One of the members selected and appointed by the remaining members of the Airport Authority shall serve a two-year term. One of the members selected and appointed by the remaining members of the Airport Authority shall serve a three-year term. One of the members selected and appointed by the remaining members of the Airport Authority shall serve a four-year term.

SECTION 1.(c) Section 16 of S.L. 2022-34 is repealed.

SECTION 2. This act is effective when it becomes law.
