1 A BILL TO BE ENTITLED
2 AN ACT TO REVISE JUDICIAL DISTRICTS.

3 Whereas, Section 9 of Article IV of the North Carolina Constitution provides that
4 the General Assembly shall, from time to time, divide the State into a convenient number of
5 Superior Court judicial districts; and

6 Whereas, Section 10 of Article IV of the North Carolina Constitution provides that
7 the General Assembly shall, from time to time, divide the State into a convenient number of
8 local court districts for the holding of District Courts; and

9 Whereas, Section 11 of Article IV of the North Carolina Constitution requires the
10 rotation of Superior Court Judges among the various districts of a division and authorizes the
11 General Assembly to divide the State into a number of judicial divisions for this purpose; and

12 Whereas, Section 18 of Article IV of the North Carolina Constitution provides that
13 the General Assembly shall, from time to time, divide the State into a convenient number of
14 prosecutorial districts; and

15 Whereas, the last comprehensive reforms to the judicial and prosecutorial districts
16 were made in the 1960s for the purpose of establishing a unified court system; and

17 Whereas, in the 50 years since the comprehensive reforms of the 1960s, there have
18 been only uncoordinated and piecemeal changes to the judicial and prosecutorial districts,
19 which have been inconsistent with and contrary to the objective of preserving a unified court
20 system; and

21 Whereas, the uncoordinated and piecemeal changes made to the judicial and
22 prosecutorial districts over the last 50 years have resulted in overlapping and unbalanced
23 districts in which judicial resources are not efficiently allocated according to the particular
24 needs of each district; and

25 Whereas, the General Assembly recognizes the need to enact a comprehensive
26 reform of the judicial and prosecutorial districts to further the original objective of establishing
27 and preserving a unified court system that will promote the more efficient allocation of judicial
28 resources in order to better serve the citizens of our State; Now, therefore,
29 The General Assembly of North Carolina enacts:

30 **SECTION 1.(a)** G.S. 7A-41 is repealed.

31 **SECTION 1.(b)** Article 7 of Chapter 7A of the General Statutes is amended by
32 adding a new section to read:

33 **"§ 7A-40.5. Judicial divisions and superior court districts; number of judges.**

23 official ballot in accordance with this subdivision.

26 (5) A means by which the voter may cast write-in votes, as provided in
27 G.S. 163-123. No space for write-ins is required unless a write-in candidate
28 has qualified under G.S. 163-123 or unless the ballot item is exempt from
29 G.S. 163-123.
30 (6) Instructions to voters, unless the State Board of Elections allows instructions
31 to be placed elsewhere than on the official ballot.
32 (7) The printed title and facsimile signature of the chair of the county board of
33 elections.
34 (8) The designation of vacancy sought, if there are two or more vacancies for an
35 elected office. The designation shall not be the name or names of any
36 incumbent or other individual, but shall be designated as determined by the
37 State Board."

38 **SECTION 4.(b)** G.S. 163-106, as amended by Section 21(a) of S.L. 2016-125 and
39 Section 5 of S.L. 2017-3, reads as rewritten:

40 **"§ 163-106. Notices of candidacy; pledge; with whom filed; date for filing; withdrawal.**

42 (d) Notice of Candidacy for Certain Offices to Indicate Vacancy. – In any primary in
43 which there are two or more vacancies for associate justices for the Supreme Court, two or
44 more vacancies for the Court of Appeals, two or more vacancies for district court judge, or two
45 vacancies for United States Senator from North Carolina, each candidate shall, at the time of
46 filing notice of candidacy, file with the State Board of Elections a written statement designating
47 the vacancy to which the candidate seeks nomination. The designation shall not be the name or
48 names of any incumbent or other individual, but shall be designated as determined by the State
49 Board. A person seeking election for a specialized district judgeship established under
50 G.S. 7A-147 shall, at the time of filing notice of candidacy, file with the State Board of
51 Elections a written statement designating the specialized judgeship to which the person seeks

1 nomination. Votes cast for a candidate shall be effective only for nomination to the vacancy for
2 which the candidate has given notice of candidacy as provided in this subsection.

4 **SECTION 5.** The Administrative Office of the Courts, the Courts Commission,
5 and the Legislative Services Commission shall study and determine quantifiable workload
6 assessments, by county, for prosecutorial, district, and superior courts to assist the General
7 Assembly in dividing the State into a convenient number of districts and divisions for the
8 administration of the judicial branch. The Courts Commission shall make a report to the 2019
9 Regular Session of the General Assembly on or before December 15, 2018, with any
10 recommendations of the study.

11 **SECTION 6.** This act becomes effective January 1, 2019, and, except as provided
12 in this act, elections in 2018 and thereafter shall be held accordingly.
