Short Title: Display of American Flag. (Public) Sponsors: Referred to: April 3, 2003 A BILL TO BE ENTITLED 1 AN ACT PERTAINING TO THE DISPLAY OF THE UNITED STATES FLAG. 2 3 The General Assembly of North Carolina enacts: 4 **SECTION 1.** Chapter 144 of the General Statutes is amended by adding a 5 new section to read: "§ 144-7. Display of the American flag; private restrictions. 6 No private restriction on the use of land shall be construed to regulate or prohibit the 7 8 display of the flag of the United States, of a size no greater than four feet by six feet, 9 which is displayed in accordance with the patriotic customs set forth in 4 U.S.C.A. §§ 5-10, as amended, governing the display and use of the flag of the United States unless: 10 For restrictions registered prior to October 1, 2003, the restriction 11 (1) specifically uses the following terms: 12 13 Flag of the United States of America; a. American flag; or 14 b. 15 United States flag. For restrictions registered on or after October 1, 2003, the restriction 16 (2) 17 shall be written on the first page of the instrument or conveyance in print that is in boldface type, capital letters, and no smaller than the 18 largest print used elsewhere in the instrument or conveyance. The 19 20 restriction shall be construed to regulate or prohibit the display of the United States flag only if the restriction specifically states: 'THIS 21 DOCUMENT REGULATES OR PROHIBITS THE DISPLAY 22 OF THE FLAG OF THE UNITED STATES OF AMERICA'. 23 This section shall apply to owners of property who display the flag of the United 24 25 States on their property and does not apply to common areas, easements, rights-of-way,

1	SECTION 2. Chapter 144 of the General Statutes is amended by adding a

3	"§ 144-7.1. Display of the American flag; public restrictions.
4	(a) A unit of local government shall not prohibit the flag of the United States
5	from being flown or displayed if the flag is flown or displayed:
6	(1) In accordance with the patriotic customs set forth in 4 U.S.C.A. §§
7	5-10, as amended, governing the display and use of the flag of the
8	United States, and
9	(2) Upon private or public property with the consent of either the owner of
10	the property or of any person having lawful control of the property.
11	(b) Notwithstanding subsection (a) of this section, for the purpose of protecting
12	the public health, safety, and welfare, reasonable restrictions on flag size, number of
13	flags, location, and height of flagpoles are not prohibited provided that such restrictions
14	shall not discriminate against the flag in any manner."
15	SECTION 3. The title of Chapter 144 of the General Statutes reads as
16	rewritten:
17	"State Flag, American Flag, Motto Motto, And Colors."
18	SECTION 4. This act becomes effective October 1, 2003, but it applies to
19	the construction of instruments or ordinances adopted or registered prior to its effective
20	date.
