1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A  
3 RETIRED PIEDMONT AIRLINES PILOT SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) is amended by adding a new subdivision to  
6 read:

7 "(b) Types. – The Division shall issue the following types of special registration  
8 plates:

9 ...

10 (36c) Retired Piedmont Airlines Employee. – This plate is issuable to a  
11 retired Piedmont Airlines employee presenting to the Division, along  
12 with the application for the plate, a copy of the employee's letter of  
13 retirement. The plate authorized by this subdivision shall bear the phrase  
14 "PA" and the Piedmont Speed Bird Logo. The Division may not issue a  
15 plate authorized by this subdivision until it has received 300 or more  
16 applications for this plate."

17 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

18 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one  
19 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled  
20 veteran, and an ex-prisoner of war. All other special registration plates, including  
21 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of  
22 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or  
23 G.S. 20-88 plus an additional fee in the following amount:

**SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

5           **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

6           "(b53) Retired Piedmont Airlines Pilot. – The Division must receive 300 or more  
7 applications for a Retired Piedmont Airlines Pilot plate before the plate may be  
8 developed. The Division must transfer quarterly the money in the Collegiate and  
9 Cultural Attraction Plate Account derived from the sale of Retired Piedmont Airlines  
10 Pilot plates to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships  
11 and family assistance for retired Piedmont Airlines employees and their families,  
12 including surviving spouses and dependents, suffering economic hardship."

13           **SECTION 5.** This act is effective when it becomes law.
