A BILL TO BE ENTITLED

1 AN ACT TO APPROPRIATE FUNDS TO PURCHASE EQUIPMENT FOR  
2 VOLUNTEER FIRE DEPARTMENTS IN PERSON, CASWELL, AND  
3 NORTHERN DURHAM COUNTIES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** There is appropriated from the General Fund to Person County  
7 the sum of fourteen thousand dollars (\$14,000) for the 2006-2007 fiscal year to be used  
8 to purchase equipment for the County's seven volunteer fire departments. These funds  
9 shall be allocated equally among the following:

- 10 (1) Ceffo Volunteer Fire & Rescue Department.  
11 (2) Moriah Volunteer Fire & Rescue Department.  
12 (3) Hurdle Mills Volunteer Fire Department.  
13 (4) Timberlake Volunteer Fire & Rescue.  
14 (5) Triple Springs Volunteer Fire Department.  
15 (6) Allensville Volunteer Fire Department.  
16 (7) Woodsdale Volunteer Fire Department.

17 **SECTION 2.** There is appropriated from the General Fund to Durham  
18 County the sum of four thousand dollars (\$4,000) for the 2006-2007 fiscal year to be  
19 used to purchase equipment for the two volunteer fire departments that serve areas of  
20 Northern Durham County. These funds shall be allocated equally among the following:

- 21 (1) Lebanon Volunteer Fire Department.  
22 (2) Bahama Volunteer Fire and Rescue.

23 **SECTION 3.** There is appropriated from the General Fund to Caswell  
24 County the sum of twenty thousand dollars (\$20,000) for the 2006-2007 fiscal year to  
25 be used to purchase equipment for the County's 10 volunteer fire departments. These  
26 funds shall be allocated equally among the following:

- 27 (1) Yanceyville Volunteer Fire and Rescue.  
28 (2) Milton Volunteer Fire Department.  
29 (3) Casville Volunteer Fire Department.

- 1           (4)    Providence Fire and Rescue.
- 2           (5)    Prospect Hill Volunteer Fire Department.
- 3           (6)    Pelham Volunteer Fire Department.
- 4           (7)    Semora Volunteer Fire Department.
- 5           (8)    Cherry Grove Volunteer Fire Department.
- 6           (9)    Anderson Township Volunteer Fire Department.
- 7           (10)  Leasburg Volunteer Fire Department.
- 8           **SECTION 4.** This act becomes effective July 1, 2006.
