4	The General Assembly of North Carolina enacts:
5	SECTION 1. Article 19 of Chapter 1 of the General Statutes is amended by
6	adding a new section to read:
7	" <u>§ 1-186.1. Attorneys' fees awarded to prevailing party.</u>
8	(a) General Rule The prevailing party is entitled to receive an award of
9	attorneys' fees from the nonprevailing party with respect to, and only to the extent that
10	party prevails on, any claim advanced during the litigation, except that the sum of the
11	attorneys' fees awarded under this section shall not exceed the attorneys' fees of the
12	nonprevailing party with regard to the claim. If the nonprevailing party received
13	services under a contingent fee agreement, the sum of the attorneys' fees awarded under
14	this section shall not exceed the reasonable value of those services.
15	(b) Discretion. – The court may, in its discretion, limit the fees recovered under
16	subsection (a) of this section if it considers payment of these fees unjust.
17	(c) <u>Records. – Counsel of record in actions subject to an award of attorneys' fees</u>
18	under this section shall maintain accurate, up-to-date records of hours worked on the
19	matter regardless of the fee arrangement with the client.
20	(d) Statutory Exceptions. – This section does not apply when a specific statute
21	otherwise addresses an award of attorneys' fees."
22	SECTION 3. This act becomes effective October 1, 2005, and applies to
23	actions filed on or after that date.
