A JOINT RESOLUTION PROVIDING FOR A JOINT SESSION OF THE GENERAL 1 2 ASSEMBLY TO ACT ON A JOINT RESOLUTION PROVIDING FOR 3 CONFIRMATION OF THE APPOINTMENTS BY THE GOVERNOR OF NEW MEMBERS TO THE STATE BOARD OF EDUCATION, AND PROVIDING FOR 4 A JOINT SESSION OF THE GENERAL ASSEMBLY TO DETERMINE BY 5 6 JOINT BALLOT THE CONTESTED ELECTION FOR SUPERINTENDENT OF 7 PUBLIC INSTRUCTION. 8 Whereas, under the provisions of the Constitution of North Carolina and 9 G.S. 115C-10, appointments by the Governor to membership on the State Board of 10 Education are subject to confirmation by the General Assembly in joint session; and Whereas, vacancies have occurred on the State Board of Education; and 11 Whereas, the Governor will transmit to the presiding officers of the Senate 12 and the House of Representatives the names of his appointees to fill the terms of 13 membership on the State Board of Education which expire March 31, 2013; and 14 Whereas, Article VI, Section 2 of the Constitution of North Carolina provides 15 that a contested election for any office established by Article III of this Constitution 16 shall be determined by joint ballot of both houses of the General Assembly in the 17 manner prescribed by law; and 18 19 Whereas, G.S. 163-182.13A(d) provides for the appointment of a joint select 20 committee to initially hear the contest, and that the committee shall report its findings as 21 to the law and the facts and make recommendations to the General Assembly for its 22 action: and 23 Whereas, that committee has been appointed, met, and made findings and 24 recommendations; and 25 Whereas, G.S. 163-182.13A(e) provides that the final determination on the recommendations of the committee shall be made by the General Assembly, both 26 houses sitting in joint session in the Hall of the House of Representatives, with the 27 Speaker of the House of Representatives presiding; Now, therefore, 28

## **General Assembly of North Carolina**

1 SECTION 1. Upon the call of the President Pro Tempore of the Senate and 2 the Speaker of the House of Representatives, the General Assembly shall meet in joint 3 session to act on a joint resolution providing for confirmation of the appointments by 4 the Governor of new members to the State Board of Education.

5 **SECTION 2.** Upon the call of the President Pro Tempore of the Senate and 6 the Speaker of the House of Representatives, the General Assembly shall meet in joint 7 session to determine the contested election for Superintendent of Public Instruction by 8 joint ballot.
