3	ANY PERSON CONVICTED OF GIVING ALCOHOLIC BEVERAGES TO, OR

7	The General Assembly of North Carolina enacts:
8	SECTION 1. G.S. 18B-302(g) reads as rewritten:
9	"(g) Conviction Report Sent to Division of Motor Vehicles. – The court shall file a
10	conviction report with the Division of Motor Vehicles indicating the name of the person
11	convicted and any other information requested by the Division if the person is convicted
12	of: of any of the following:
13	(1) A violation of subsection (e) or (f) of this section; or section.
14	(2) A violation of subdivision $(c)(1)$ subsection (c) of this section; or
15	(3) A violation of subsection (b) of this section, if the violation occurred
16	while the person was purchasing or attempting to purchase an
17	alcoholic beverage.
18	(4) <u>A violation of subsection (a) of this section, if the violation occurred</u>
19	while the person was giving an alcoholic beverage to an underage
20	person.
21	Upon receipt of a conviction report, the Division shall revoke the person's license as
22	required by G.S. 20-17.3."
23	SECTION 2. G.S. 20-17.3 reads as rewritten:
24	"§ 20-17.3. Revocation for underage purchasers of alcohol.
25	The Division shall revoke for one year the driver's license of any person who has
26	been convicted of violating any of the following:
27	(1) $G.S. 18B - 302(c)(1), G.S. 18B - 302(c), (e), or (f); or$

 (2) G.S. 18B-302(b), if the violation occurred while the person was purchasing or attempting to purchase an alcoholic beverage. (3) G.S. 18B-302(a), except that this subdivision shall only apply if the violation occurred while the person was giving an alcoholic beverage to an underage person. 12 "§ 18B-302.2. Notification of penalties; loss of drivers license for certain offenses.
13 Each ABC Store and each person that sells alcoholic beverages shall display o
14 cause to be displayed warning signs that inform the public that it is a crime to give an
15 alcoholic beverage to an underage person, that it is a crime to aid and abet an underage
16 person who purchases an alcoholic beverage, and that the punishment for these offense
17 includes the loss of driving privileges under G.S. 20-17.3. The Commission shal
18 develop the warning signs which shall be similar in size and design to those required
19 under G.S. 18B-808."
20 SECTION 4. This act becomes effective December 1, 2005, and applies to
21 offenses committed on or after that date.
