| 5  | Whereas, several of the old courthouses in the Western part of the State are              |
| 6  | listed on the National Register of Historic Places, including those in the Towns of       |
| 7  | Bakersville, Bryson City, Hayesville, Marshall, and Waynesville; and                      |
| 8  | Whereas, these historic courthouses need repairs and renovation to upgrade                |
| 9  | them for the continued use by the public for educational, cultural, and civic activities; |
| 10 | Now, therefore,   |
| 11 | The General Assembly of North Carolina enacts:  |
| 12 | <b>SECTION 1.</b> There is appropriated from the General Fund to Clay County              |
| 13 | the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal year for     |
| 14 | architectural work, renovation, and repair of the old courthouse in Hayesville.           |
| 15 | SECTION 2. There is appropriated from the General Fund to Haywood                         |
| 16 | County the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal       |
| 17 | year for architectural work, renovation, and repair of the old courthouse in Waynesville. |
| 18 | SECTION 3. There is appropriated from the General Fund to Madison                         |
| 19 | County the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal       |
| 20 | year for architectural work, renovation, and repair of the old courthouse in Marshall.    |
| 21 | SECTION 4. There is appropriated from the General Fund to Mitchell                        |
| 22 | County the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal       |
| 23 | year for architectural work, renovation, and repair of the old courthouse in Bakersville. |
| 24 | <b>SECTION 5.</b> There is appropriated from the General Fund to Swain County             |
| 25 | the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal year for     |
| 26 | architectural work, renovation, and repair of the old courthouse in Bryson City.          |
| 27 | <b>SECTION 6.</b> This act becomes effective July 1, 2007.                                |
