A BILL TO BE ENTITLED

AN ACT TO PROVIDE IN POLK COUNTY FOR REFERENDA ON ANNEXATIONS IF REQUESTED BY RESIDENTS OF THE AREA TO BE ANNEXED AND TO GENERALLY PROHIBIT SUBDIVISIONS FROM BEING DIVIDED DURING AN INVOLUNTARY ANNEXATION.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 160A-37(e) reads as rewritten:

- Passage of the Annexation Ordinance. The municipal governing board shall take into consideration facts presented at the public hearing and shall have authority to amend the report required by G.S. 160A-35 to make changes in the plans for serving the area proposed to be annexed so long as such changes meet the requirements of G.S. 160A-35. At any regular or special meeting held no sooner than the tenth day following the public hearing and not later than 90 days following such public hearing, the governing board shall have authority to adopt an ordinance extending the corporate limits of the municipality to include all, or such part, of the area described in the notice of public hearing which meets the requirements of G.S. 160A-36 and which the governing board has concluded should be annexed, provided if no later than adjournment of the public hearing, a petition, signed by the owners of twenty percent (20%) of the registered voters in the area proposed to be annexed is received by the city, opposing the annexation, then the annexation ordinance shall become effective only if approved by the voters of the area to be annexed in a referendum conducted under subsection (e1) of this section. Prior to being submitted to the city, the petition must be verified by the board or boards of elections administering elections for that city. The ordinance shall:
 - (1) Contain specific findings showing that the area to be annexed meets the requirements of G.S. 160A-36. The external boundaries of the area to be annexed shall be described by metes and bounds. In showing the

application of G.S. 160A-36(c) and (d) to the area, the governing 1 2 board may refer to boundaries set forth on a map of the area and 3 incorporate same by reference as a part of the ordinance. 4 A statement of the intent of the municipality to provide services to the (2) 5 area being annexed as set forth in the report required by G.S. 160A-35. 6 (3) A specific finding that on the effective date of annexation the 7 municipality will have funds appropriated in sufficient amount to 8 finance construction of any water and sewer lines found necessary in 9 the report required by G.S. 160A-35 to extend the basic water and/or 10 sewer system of the municipality into the area to be annexed, or that 11 on the effective date of annexation the municipality will have authority 12 to issue bonds in an amount sufficient to finance such construction. If 13 authority to issue such bonds must be secured from the electorate of 14 the municipality prior to the effective date of annexation, then the 15 effective date of annexation shall be no earlier than the day following the statement of the successful result of the bond election. 16 17 (4) Fix the effective date for annexation. The effective date of annexation 18 may be fixed for any date not less than 40 days nor more than 400 days 19 from the date of passage of the ordinance." 20 **SECTION 2.** G.S. 160A-37 is amended by adding a new subsection to read: 21 "(e1) Conduct of Election. – If a referendum is required under subsection (e) of this 22 section, the city council shall order the board or boards of elections which conduct 23 elections for that city to call an election to determine whether or not the proposed 24 territory shall be annexed to the city or town. Within 100 days after receiving the order 25 from the governing body, the county board of elections shall proceed to hold an election 26 on the question. 27 The election shall be called by a resolution or resolutions of the county board of 28 elections which shall: 29 Describe the territory proposed to be annexed to the city or town as set (1) 30 out in the order of the local governing body. 31 Provide that the matter of annexation of the territory shall be submitted (2) 32 to the vote of the qualified voters of the territory proposed to be 33 annexed. 34 Provide for registration of voters in the territory proposed to be (3) 35 annexed for the election in accordance with G.S. 163-288.2. 36 The resolution shall be published in one or more newspapers of the county once a week for 30 days prior to the closing of the registration books. All costs of holding the 37 38 election shall be paid by the city or town. Except as herein provided, the election shall 39 be held under the same statutes, rules, and regulations as are applicable to elections in

If a majority of the votes cast from the area proposed for annexation shall be 'For Annexation', the annexation ordinance shall become effective as provided by this Part."

SECTION 3. G.S. 160A-49(e) reads as rewritten:

- Passage of the Annexation Ordinance. The municipal governing board shall take into consideration facts presented at the public hearing and shall have authority to amend the report required by G.S. 160A-47 to make changes in the plans for serving the area proposed to be annexed so long as such changes meet the requirements of G.S. 160A-47, provided that if the annexation report is amended to show additional subsections of G.S.160A-48(c) or (d) under which the annexation qualifies that were not listed in the original report, the city must hold an additional public hearing on the annexation not less than 30 nor more than 90 days after the date the report is amended, and notice of such new hearing shall be given at the first public hearing. At any regular or special meeting held no sooner than the tenth day following the public hearing and not later than 90 days following such public hearing, the governing board shall have authority to adopt an ordinance extending the corporate limits of the municipality to include all, or such part, of the area described in the notice of public hearing which meets the requirements of G.S. 160A-48 and which the governing board has concluded should be annexed, provided if no later than adjournment of the public hearing, a petition, signed by the owners of twenty percent (20%) of the registered voters in the area proposed to be annexed is received by the city, opposing the annexation, then the annexation ordinance shall become effective only if approved by the voters of the area to be annexed in a referendum conducted under subsection (e1) of this section. Prior to being submitted to the city, the petition must be verified by the board or boards of elections administering elections for that city. The ordinance shall:
 - (1) Contain specific findings showing that the area to be annexed meets the requirements of G.S. 160A-48. The external boundaries of the area to be annexed shall be described by metes and bounds.  - (3) A specific finding that on the effective date of annexation the municipality will have funds appropriated in sufficient amount to finance construction of any major trunk water mains and sewer outfalls and such water and sewer lines as required in G.S. 160A-47(3)b found necessary in the report required by G.S. 160A-47 to extend the basic water and/or sewer system of the municipality into the area to be annexed, or that on the effective date of annexation the municipality will have authority to issue bonds in an amount sufficient to finance such construction. If authority to issue such bonds must be secured from the electorate of the municipality prior to the effective date of annexation, then the effective date of annexation shall be no earlier

than the day following the statement of the successful result of the bond election.

(4) Fix the effective date for annexation. The effective date of annexation may be fixed for any date not less than 70 days nor more than 400 days from the date of passage of the ordinance."

SECTION 4. G.S. 160A-49 is amended by adding a new subsection to read:

"(e1) Conduct of Election. – If a referendum is required under subsection (e) of this section, the city council shall order the board or boards of elections which conduct elections for that city to call an election to determine whether or not the proposed territory shall be annexed to the city or town. Within 100 days after receiving the order from the governing body, the county board of elections shall proceed to hold an election on the question.

The election shall be called by a resolution or resolutions of the county board of elections which shall:

- Describe the territory proposed to be annexed to the city or town as set (1) out in the order of the local governing body.
- **(2)** Provide that the matter of annexation of the territory shall be submitted to the vote of the qualified voters of the territory proposed to be annexed.
- Provide for registration of voters in the territory proposed to be **(3)** annexed for the election in accordance with G.S. 163-288.2.

The resolution shall be published in one or more newspapers of the county once a week for 30 days prior to the closing of the registration books. All costs of holding the election shall be paid by the city or town. Except as herein provided, the election shall be held under the same statutes, rules, and regulations as are applicable to elections in the municipality whose corporate limits are being enlarged.

In the election, the question on the ballot shall be:

'[] FOR [] AGAINST Annexation.'

If a majority of the votes cast from the area proposed for annexation shall be 'For Annexation', the annexation ordinance shall become effective as provided by this Part."

SECTION 5. G.S. 160A-36(b) reads as rewritten:

- "(b) The total area to be annexed must meet the following standards:
 - It must be adjacent or contiguous to the municipality's boundaries at (1) the time the annexation proceeding is begun, except if the entire territory of a county water and sewer district created under G.S. 162A-86(b1) is being annexed, the annexation shall also include any noncontiguous pieces of the district as long as the part of the district with the greatest land area is adjacent or contiguous to the municipality's boundaries at the time the annexation proceeding is begun.
 - (2) At least one eighth of the aggregate external boundaries of the area must coincide with the municipal boundary.
