1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
3 DONATE LIFE SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-63(b) reads as rewritten:

6 "(b) Every license plate shall have displayed upon it the registration number assigned to
7 the vehicle for which it is issued, the name of the State of North Carolina, which may be
8 abbreviated, and the year number for which it is issued or the date of expiration. A plate issued
9 for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more,
10 must bear the word "commercial," unless the plate is a special registration plate authorized in
11 G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The
12 plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word
13 "weighted".

14 Except as otherwise provided in this subsection, a registration plate issued by the Division
15 for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less
16 shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight"
17 printed at the top of the plate above all other letters and numerals. The background of the plate
18 shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying
19 slightly upward and to the right. The following special registration plates do not have to be a
20 "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be
21 approved by the Division and the State Highway Patrol for clarity and ease of identification.

13 **SECTION 2.** G.S. 20-79.4(b) reads as rewritten:

14 "(b) Types. – The Division shall issue the following types of special registration plates:

15 ...

16 (39a) Donate Life. – Issuable to the registered owner of a motor vehicle in
 17 accordance with G.S. 20-81.12. The plate shall bear the phrase "Donate
 18 Life" with a logo designed by Donate Life North Carolina.

20 **SECTION 3.** G.S. 20-79.7(a) reads as rewritten:

21 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
 22 registration plate to a recipient of a Legion of Valor award, a 100% disabled veteran, and an
 23 ex-prisoner of war. All other special registration plates, including additional Legion of Valor,
 24 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle
 25 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

SECTION 4. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

51 **SECTION 5.** G.S. 20-81.12 is amended by adding a new subsection to read:

1 "(b73) Donate Life. – The Division must receive 300 or more applications for the Donate
2 Life plate before the plate may be developed. The Division must transfer quarterly the money
3 in the Collegiate and Cultural Attraction Plate Account derived from the sale of Donate Life
4 plates to Donate Life North Carolina to be divided equally among the transplant centers in
5 North Carolina to include Bowman Gray Medical Center, Carolina's Medical Center, Duke
6 University, East Carolina University, and the University of North Carolina at Chapel Hill. The
7 transplant centers shall use all of the proceeds received from this plate to provide funding for
8 expenses incurred by needy families, recipients, and expenses related to organ donation."

9 **SECTION 6.** This act becomes effective July 1, 2009.
