2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
3 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.
4 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
5 appointments to public offices upon the recommendation of the Speaker of the House of
6 Representatives; and
7 Whereas, the Speaker of the House of Representatives has made recommendations;
8 Now, therefore,
9 The General Assembly of North Carolina enacts:

11 **PART I. SPEAKER'S RECOMMENDATIONS**

12 **SECTION 1.1.** Effective October 1, 2012, Lavonda R. Daniels of Durham County
13 is appointed to the African-American Heritage Commission for a term expiring on September
14 30, 2015.

15 **SECTION 1.2.** Thomas C. Hege of Davidson County is appointed to the North
16 Carolina Agriculture Finance Authority for a term expiring on June 30, 2015.

20 Moore County (Seat 7) for a term expiring on June 30, 2014, Raymond T. Covington of
21 Guilford County (Seat 4) and Christopher J. Ayers of Wake County (Seat 6) for terms expiring
22 on June 30, 2015, and Charles Taylor of Lee County (Seat 5) for a term expiring on June 30,
23 2016.

24 **SECTION 1.30.(a)** Effective January 1, 2013, Robert Smith of Mecklenburg
25 County, Richard Isherwood of Mecklenburg County, and Jean Thaxton of Alamance County
26 are appointed to the 911 Board for terms expiring on December 31, 2016.

27 **SECTION 1.30.(b)** Sheriff Len D. Hagaman, Jr., of Watauga County is appointed
28 to the 911 Board for a term expiring on December 31, 2014, to fill the unexpired term of
29 Sheriff Rick Davis.

30 **SECTION 1.31.** Benjamin C. Hobbs of Chowan County, Steven E. Howell of
31 Northampton County, and Donny L. Lassiter of Northampton County are appointed to the
32 North Carolina's Northeast Commission for a term expiring on June 30, 2014.

35 expiring on June 30, 2015.
