1 A HOUSE RESOLUTION RECOGNIZING THE THIRD WEDNESDAY OF MAY AS  
2 HYPERTENSION/HIGH BLOOD PRESSURE AWARENESS DAY, AS  
3 RECOMMENDED BY THE JUSTUS-WARREN HEART DISEASE AND STROKE  
4 PREVENTION TASK FORCE.

5 Whereas, the health of our citizens is the foundation for a caring and productive  
6 society, and our future rests with our ability to adequately treat, and ultimately to prevent, a  
7 variety of illnesses including high blood pressure; and

8 Whereas, heart disease and stroke are the second and fourth leading causes of death  
9 in North Carolina, and high blood pressure, also known as hypertension, is a major and  
10 modifiable risk factor for heart disease and stroke and is a major contributor to adult disability;  
11 and

12 Whereas, in 2011, 32.4% of North Carolina adults reported a health professional  
13 telling them that they had high blood pressure; and

14 Whereas, current awareness and treatment for high blood pressure is not adequate;  
15 and

16 Whereas, about seven out of every 10 people having their first heart attack have  
17 high blood pressure and about eight out of every 10 people having their first stroke have high  
18 blood pressure; and

19 Whereas, adequate medical treatments and proven preventive health strategies, such  
20 as healthy lifestyles that include a low-salt diet with more fruits and vegetables, are beneficial;  
21 and

22 Whereas, high blood pressure patients who are treated earlier have a longer life  
23 expectancy; and

24 Whereas, education can help with early diagnosis, prevention, and better treatment;  
25 and

26 Whereas, the North Carolina Department of Health and Human Services recognizes  
27 that the prevention and management of high blood pressure will require the collective effort of  
28 health care providers, other community members and organizations, and patients and families;  
29 and

30 Whereas, the Justus-Warren Heart Disease and Stroke Prevention Task Force, the  
31 American Heart Association/American Stroke Association, the North Carolina Academy of  
32 Family Physicians, the Consortium on Southeastern Hypertension Control, and the Carolinas  
33 Center for Medical Excellence are organizations that have agreed to support the  
34 Hypertension/High Blood Pressure Awareness Day scheduled for Wednesday, May 21, 2014.



1 And these partners, along with other North Carolina organizations, seek ways to improve health  
2 for the citizens of North Carolina by improving prevention and treatment of high blood  
3 pressure through support of education, advocacy, and awareness; Now, therefore,  
4 Be it resolved by the House of Representatives:

5           **SECTION 1.** The House of Representatives joins the Justus-Warren Heart Disease  
6 and Stroke Prevention Task Force and other organizations mentioned in this resolution in  
7 recognizing the third Wednesday in May to be Hypertension/High Blood Pressure Awareness  
8 Day and urges all the citizens of the State of North Carolina to recognize the seriousness of this  
9 disease and the meritorious work of the public health and health care provider community in  
10 the prevention and treatment of this disease.

11           **SECTION 2.** This resolution is effective upon adoption.
