4	The General Assembly of North Carolina enacts:
5	<b>SECTION 1.</b> G.S. 143-138(g) reads as rewritten:
6	"§ 143-138. North Carolina State Building Code.
7	
8	(g) Publication and Distribution of Code. – The Building Code Council shall cause to
9	be printed, printed and posted to the Council's Web site after adoption by the Council, the North
10	Carolina State Building Code and each amendment thereto. As used in this subsection, "posted
11	to the Council's Web site" includes posting in a form that can be printed and downloaded free
12	of charge. It shall, at the State's expense, distribute copies of the Code and each amendment to
13	State and local governmental officials, departments, agencies, and educational institutions, as is
14	set out in the table below. (Those marked by an asterisk will receive copies only on written
15	request to the Council.)
