2 AN ACT TO PROVIDE FURTHER REGULATORY RELIEF TO THE CITIZENS OF  
3 NORTH CAROLINA.

4 The General Assembly of North Carolina enacts:

5  
6 **PART I. BUSINESS REGULATION**

7  
8 **EMPLOYMENT STATUS OF FRANCHISES**

9 **SECTION 1.1.** Article 2A of Chapter 95 of the General Statutes is amended by  
10 adding a new section to read:

11 **"§ 95-25.24A. Franchisee status.**

12 Neither a franchisee nor a franchisee's employee shall be deemed to be an employee of the  
13 franchisor for any purposes, including, but not limited to, this Article and Chapters 96, 97, and  
14 105 of the General Statutes. For purposes of this section, "franchisee" and "franchisor" have the  
15 same definitions as set out in 16 C.F.R. § 436.1."  
16

17 **STREAMLINE MORTGAGE NOTICE REQUIREMENTS**

18 **SECTION 1.2.** G.S. 45-91 reads as rewritten:

19 **"§ 45-91. Assessment of fees; processing of payments; publication of statements.**

20 A servicer must comply as to every home loan, regardless of whether the loan is considered  
21 in default or the borrower is in bankruptcy or the borrower has been in bankruptcy, with the  
22 following requirements:

23 (1) Any fee that is incurred by a servicer shall be both:

24 a. Assessed within 45 days of the date on which the fee was incurred.  
25 Provided, however, that attorney or trustee fees and costs incurred as  
26 a result of a foreclosure action shall be assessed within 45 days of the  
27 date they are charged by either the attorney or trustee to the servicer.

28 b. Explained clearly and conspicuously in a statement mailed to the  
29 borrower at the borrower's last known address within 30 days after  
30 assessing the fee, provided the servicer shall not be required to take  
31 any action in violation of the provisions of the federal bankruptcy  
32 code. The servicer shall not be required to send such a statement for a  
33 fee ~~that: (i) results that either:~~



- 1                                1. Is otherwise included in a periodic statement sent to the
- 2                                borrower that meets the requirements of paragraphs (b), (c),
- 3                                and (d) of 12 C.F.R. § 1026.41.
- 4                                2. Results from a service that is affirmatively requested by the
- 5                                borrower, ~~(ii)~~ is paid for by the borrower at the time the
- 6                                service is provided, and ~~(iii)~~ is not charged to the borrower's
- 7                                loan account.
- 8                                (2) All amounts received by a servicer on a home loan at the address where the
- 9                                borrower has been instructed to make payments shall be accepted and
- 10                               credited, or treated as credited, within one business day of the date received,
- 11                               provided that the borrower has made the full contractual payment and has
- 12                               provided sufficient information to credit the account. If a servicer uses the
- 13                               scheduled method of accounting, any regularly scheduled payment made
- 14                               prior to the scheduled due date shall be credited no later than the due date.
- 15                               Provided, however, that if any payment is received and not credited, or
- 16                               treated as credited, the borrower shall be notified within 10 business days by
- 17                               mail at the borrower's last known address of the disposition of the payment,
- 18                               the reason the payment was not credited, or treated as credited to the
- 19                               account, and any actions necessary by the borrower to make the loan current.
- 20                               (2a) The notification required by subdivision (2) of this section is not necessary if
- 21                               (i) the servicer complies with the terms of any agreement or plan made with
- 22                               the borrower and has applied and credited payments received in the manner
- 23                               required, and (ii) the servicer is applying and crediting payments to the
- 24                               borrower's account in compliance with all applicable State and federal laws,
- 25                               including bankruptcy laws, and if at least one of the following occurs:
- 26                               a. The borrower has entered into a written loss mitigation, loan
- 27                               modification, or forbearance agreement with the servicer that
- 28                               itemizes all amounts due and specifies how payments will be applied
- 29                               and credited;
- 30                               b. The borrower has elected to participate in an alternative payment
- 31                               plan, such as a biweekly payment plan, that specifies as part of a
- 32                               written agreement how payments will be applied and credited; or
- 33                               c. The borrower is making payments pursuant to a bankruptcy plan.
- 34                               (3) Failure to charge the fee or provide the information within the allowable
- 35                               time and in the manner required under subdivision (1) of subsection (a) of
- 36                               this section constitutes a waiver of such fee.
- 37                               (4) All fees charged by a servicer must be otherwise permitted under applicable
- 38                               law and the contracts between the parties. Nothing herein is intended to
- 39                               permit the application of payments or method of charging interest which is
- 40                               less protective of the borrower than the contracts between the parties and
- 41                               other applicable law.
- 42                               (5) The obligations of mortgage servicers set forth in G.S. 53-244.110."

**CLARIFY PRIVATE DRINKING WATER WELL PERMITTING REQUIREMENTS**

**SECTION 1.3.(a)** G.S. 87-97(b1) reads as rewritten:

**"§ 87-97. Permitting, inspection, and testing of private drinking water wells.**

...

(b1) Permit to Include Authorization for Piping and Electrical. – When a permit is issued under this section, the local health department shall be responsible for notifying the appropriate building inspector of the issuance of the well permit. A permit issued under this section shall also be deemed to include authorization for all of the following:

- 1 (1) The installation, construction, maintenance, or repair of electrical wiring,  
2 devices, appliances, or equipment by a person certified as a well contractor  
3 under Article 7A of this Chapter when running electrical wires from the well  
4 pump to the pressure switch.
- 5 (2) The installation, construction, maintenance, or repair of water pipes by a  
6 person certified as a well contractor under Article 7A of this Chapter when  
7 running water pipes from the well to the water tank.
- 8 (3) The installation of both water pipes and electrical wiring in a single ditch by  
9 a person certified as a well contractor under Article 7A of this Chapter when  
10 running electrical wires from the well pump to the pressure switch and water  
11 pipes from the well to the water tank. The ditch shall be as deep as the  
12 minimum cover requirements for either electrical wiring or water pipes,  
13 whichever is greater.
- 14 (4) The local health department is the exclusive authority for the permitting and  
15 inspection of the well system. No person certified as a well contractor under  
16 Article 7 of this Chapter shall be required to have a permit under  
17 G.S. 143-138 for either (i) the connection or disconnection of a well system  
18 to the plumbing served by the well system or (ii) the connection or  
19 disconnection of the electrical wiring to the pump or pressure switch of a  
20 well system to the electrical service that serves the well system. For  
21 purposes of this subdivision, a well system includes the well, the pressure  
22 tank, the pressure switch, and all plumbing and electrical equipment in the  
23 well and between the well, pressure tank, and pressure switch.

24 This subsection shall not be interpreted to prohibit any person licensed by an independent  
25 occupational licensing board from performing any authorized services within the scope of  
26 practice of the person's license."

27 **SECTION 1.3.(b)** G.S. 143-138 is amended by adding a new subsection to read:

28 "**§ 143-138. North Carolina State Building Code.**

29 ...

30 (b17) Exclusion for Private Drinking Water Well Installation, Construction, Maintenance,  
31 and Repair. – No permit shall be required under the Code or any local variant approved under  
32 subsection (e) of this section for the electrical and plumbing activities associated with the  
33 installation, construction, maintenance, or repair of a private drinking water well when all of  
34 the following apply:

- 35 (1) The work is performed by a contractor certified under Article 7A of Chapter  
36 87 of the General Statutes under the terms of a permit issued by the local  
37 health department pursuant to G.S. 87-97.
- 38 (2) The scope of work includes only the well system as defined in  
39 G.S. 89-97(b1)(4) and the connection or disconnection of the well system to  
40 either the plumbing served by the well system or the electrical service that  
41 serves the well system.

42 ...."

43  
44 **EXEMPT CERTAIN BUILDING CODE CLASSIFICATIONS FROM ENERGY**  
45 **EFFICIENCY STANDARDS**

46 **SECTION 1.4.** G.S. 143-138 is amended by adding a new subsection to read:

47 "(b18) Exclusion From Energy Efficiency Code Requirements for Certain Use and  
48 Occupancy Classifications. – The Council shall provide for an exemption from any  
49 requirements in the energy efficiency standards pursuant to Chapter 13 of the 2012 North  
50 Carolina Building Code and the 2012 Energy Conservation Code, and any subsequent  
51 amendments to the Building Code and Energy Conservation Code, for the following use and

1 occupancy classifications pursuant to Chapter 3 of the 2012 North Carolina Building Code:  
2 Section 306, Factory Group F; Section 311, Storage Group S; and Section 312, Utility and  
3 Miscellaneous Group U."

## 5 **PART II. STATE AND LOCAL GOVERNMENT REGULATION**

### 6 7 **WILDLIFE RESOURCES COMMISSION, DIVISION OF MARINE FISHERIES, AND** 8 **UTILITIES COMMISSION PRIVATE IDENTIFYING INFORMATION**

9 **SECTION 2.1.(a)** G.S. 143-254.5 reads as rewritten:

#### 10 **"§ 143-254.5. Disclosure of personal identifying information.**

11 Social security numbers and identifying information obtained by the Commission shall be  
12 treated as provided in G.S. 132-1.10. For purposes of this section, "identifying information"  
13 also includes a person's mailing address, residence address, e-mail address, Commission-issued  
14 customer identification number, date of birth, and telephone number."

15 **SECTION 2.1.(b)** G.S. 143B-289.52(h) reads as rewritten:

#### 16 **"§ 143B-289.52. Marine Fisheries Commission – powers and duties.**

17 ...

18 (h) Social security numbers and identifying information obtained by the Commission or  
19 the Division of Marine Fisheries shall be treated as provided in G.S. 132-1.10. For purposes of  
20 this subsection, "identifying information" also includes a person's mailing address, residence  
21 address, e-mail address, Commission-issued customer identification number, date of birth, and  
22 telephone number."

23 **SECTION 2.1.(c)** Chapter 132 of the General Statutes is amended by adding a new  
24 section to read:

#### 25 **"§ 132-1.14. Personally identifiable information of public utility customers.**

26 (a) Except as otherwise provided in this section, a public record, as defined by  
27 G.S. 132-1, does not include personally identifiable information obtained by the Public Staff of  
28 the Utilities Commission from customers requesting assistance from the Public Staff regarding  
29 rate or service disputes with a public utility, as defined by G.S. 62-3(23).

30 (b) The Public Staff may disclose personally identifiable information of a customer to  
31 the public utility involved in the matter for the purpose of investigating such disputes.

32 (c) Such personally identifiable information is a public record to the extent disclosed by  
33 the customer in a complaint filed with the Commission pursuant to G.S. 62-73.

34 (d) For purposes of this section, "personally identifiable information" means the  
35 customer's name, physical address, e-mail address, telephone number, and public utility  
36 account number."

37 **SECTION 2.1.(d)** This section becomes effective October 1, 2017.

### 38 39 **WATER AND SEWER BILLING BY LESSORS**

40 **SECTION 2.2.(a)** G.S. 42-42.1 reads as rewritten:

#### 41 **"§ 42-42.1. Water and electricity conservation.**

42 (a) For the purpose of encouraging water and electricity conservation, pursuant to a  
43 written rental agreement, a landlord may charge for the cost of providing water or sewer service  
44 to tenants ~~who occupy the same contiguous premises~~ pursuant to G.S. 62-110(g) or electric  
45 service pursuant to G.S. 62-110(h).

46 (b) The landlord may not disconnect or terminate the tenant's electric service or water  
47 or sewer services due to the tenant's nonpayment of the amount due for electric service or water  
48 or sewer services."

49 **SECTION 2.2.(b)** G.S. 62-110(g) reads as rewritten:

50 (g) In addition to the authority to issue a certificate of public convenience and necessity  
51 and establish rates otherwise granted in this Chapter, for the purpose of encouraging water

1 conservation, the Commission may, consistent with the public interest, adopt procedures that  
2 allow a lessor to charge for the costs of providing water or sewer service to persons who  
3 occupy the ~~same contiguous leased~~ premises. The following provisions shall apply:

4 (1) All charges for water or sewer service shall be based on the user's metered  
5 consumption of water, which shall be determined by metered measurement  
6 of all water consumed. The rate charged by the lessor shall not exceed the  
7 unit consumption rate charged by the supplier of the service.

8 (1a) If the ~~contiguous leased~~ premises ~~were~~ are contiguous dwelling units built  
9 prior to ~~1989~~ 1989, and the lessor determines that the measurement of the  
10 tenant's total water usage is impractical or not economical, the lessor may  
11 allocate the cost for water and sewer service to the tenant using equipment  
12 that measures the tenant's hot water usage. In that case, each tenant shall be  
13 billed a percentage of the landlord's water and sewer costs for water usage in  
14 the dwelling units based upon the hot water used in the tenant's dwelling  
15 unit. The percentage of total water usage allocated for each dwelling unit  
16 shall be equal to that dwelling unit's individually submetered hot water usage  
17 divided by all submetered hot water usage in all dwelling units. The  
18 following conditions apply to billing for water and sewer service under this  
19 subdivision:

20 a. A lessor shall not utilize a ratio utility billing system or other  
21 allocation billing system that does not rely on individually  
22 submetered hot water usage to determine the allocation of water and  
23 sewer costs.

24 b. The lessor shall not include in a tenant's bill the cost of water and  
25 sewer service used in common areas or water loss due to leaks in the  
26 lessor's water mains. A lessor shall not bill or attempt to collect for  
27 excess water usage resulting from a plumbing malfunction or other  
28 condition that is not known to the tenant or that has been reported to  
29 the lessor.

30 c. All equipment used to measure water usage shall comply with  
31 guidelines promulgated by the American Water Works Association.

32 d. The lessor shall maintain records for a minimum of 12 months that  
33 demonstrate how each tenant's allocated costs were calculated for  
34 water and sewer service. Upon advanced written notice to the lessor,  
35 a tenant may inspect the records during reasonable business hours.

36 e. Bills for water and sewer service sent by the lessor to the tenant shall  
37 contain all the following information:

38 1. The amount of water and sewer services allocated to the  
39 tenant during the billing period.

40 2. The method used to determine the amount of water and sewer  
41 services allocated to the tenant.

42 3. Beginning and ending dates for the billing period.

43 4. The past-due date, which shall not be less than 25 days after  
44 the bill is mailed.

45 5. A local or toll-free telephone number and address that the  
46 tenant can use to obtain more information about the bill.

47 (2) The lessor may charge a reasonable administrative fee for providing water or  
48 sewer service not to exceed the maximum administrative fee authorized by  
49 the Commission.

50 (3) The Commission shall ~~issue~~ adopt rules to ~~define contiguous premises and to~~  
51 ~~implement this subsection. In issuing the rule to define contiguous premises,~~

~~the Commission shall consider contiguous premises where manufactured homes, as defined in G.S. 143-145(7), or spaces for manufactured homes are rented.~~

(4) The Commission shall develop an application that lessors must submit for authority to charge for water or sewer service. The form shall include all of the following:

- a. A description of the applicant and the property to be served.
- b. A description of the proposed billing method and billing statements.
- c. The schedule of rates charged to the applicant by the supplier.
- d. The schedule of rates the applicant proposes to charge the applicant's customers.
- e. The administrative fee proposed to be charged by the applicant.
- f. The name of and contact information for the applicant and its agents.
- g. The name of and contact information for the supplying water or sewer system.
- h. Any additional information that the Commission may require.

(4a) The Commission shall develop an application that lessors must submit for authority to charge for water or sewer service at single-family homes that allows the applicant to serve multiple homes in the State subject to single Commission approval. The form shall include all of the following:

- a. A description of the applicant and a listing of the address of all the properties to be served, which shall be updated annually with the Commission.
- b. A description of the proposed billing method and billing statements.
- c. The administrative fee proposed to be charged by the applicant.
- d. The name and contact information for the applicant and its agents.
- e. Any additional information the Commission may require.

(5) The Commission shall approve or disapprove an application within 30 days of the filing of a completed application with the Commission. If the Commission has not issued an order disapproving a completed application within 30 days, the application shall be deemed approved.

(6) A provider of water or sewer service under this subsection may increase the rate for service so long as the rate does not exceed the unit consumption rate charged by the supplier of the service. A provider of water or sewer service under this subsection may change the administrative fee so long as the administrative fee does not exceed the maximum administrative fee authorized by the Commission. In order to change the rate or administrative fee, the provider shall file a notice of revised schedule of rates and fees with the Commission. The Commission may prescribe the form by which the provider files a notice of a revised schedule of rates and fees under this subsection. The form shall include all of the following:

- a. The current schedule of the unit consumption rates charged by the provider.
- b. The schedule of rates charged by the supplier to the provider that the provider proposes to pass through to the provider's customers.
- c. The schedule of the unit consumption rates proposed to be charged by the provider.
- d. The current administrative fee charged by the provider, if applicable.
- e. The administrative fee proposed to be charged by the provider.

(7) A notification of revised schedule of rates and fees shall be presumed valid and shall be allowed to become effective upon 14 days notice to the

1 Commission, unless otherwise suspended or disapproved by order issued  
2 within 14 days after filing.

3 (8) Notwithstanding any other provision of this Chapter, the Commission shall  
4 determine the extent to which the services shall be regulated and, to the  
5 extent necessary to protect the public interest, regulate the terms, conditions,  
6 and rates that may be charged for the services. Nothing in this subsection  
7 shall be construed to alter the rights, obligations, or remedies of persons  
8 providing water or sewer services and their customers under any other  
9 provision of law.

10 (9) A provider of water or sewer service under this subsection shall not be  
11 required to file annual reports pursuant to G.S. 62-36 or to furnish a bond  
12 pursuant to G.S. 62-110.3."  
13

#### 14 **CLARIFY THAT RECYCLING PROGRAMS BY LOCAL SCHOOL BOARDS MUST** 15 **COMPLY WITH G.S. 160A-327**

16 **SECTION 2.3.** G.S. 115C-47(41) reads as rewritten:

17 "(41) To Encourage Recycling in Public Schools. – Local boards of education  
18 shall encourage recycling in public schools and may develop and implement  
19 recycling programs at public schools. Local boards of education shall  
20 comply with G.S. 160A-327."  
21

#### 22 **REZONING/SIMULTANEOUS COMPREHENSIVE PLAN AMENDMENT**

23 **SECTION 2.4.(a)** G.S. 153A-341 reads as rewritten:

24 "**§ 153A-341. Purposes in view.**

25 (a) Zoning regulations shall be made in accordance with a comprehensive plan.

26 (b) Prior to adopting or rejecting any zoning amendment, the governing board shall  
27 ~~adopt a statement~~ one of the following statements which shall not be subject to judicial review:

28 (1) A statement approving the zoning amendment and describing whether its  
29 action is consistent ~~its consistency~~ with an adopted comprehensive plan and  
30 explaining why the board considers the action taken to be ~~is~~ reasonable and  
31 in the public interest. ~~That statement is not subject to judicial review. The~~

32 (2) A statement rejecting the zoning amendment and describing its  
33 inconsistency with an adopted comprehensive plan and explaining why the  
34 action taken is reasonable and in the public interest.

35 (3) A statement approving the zoning amendment and containing at least all of  
36 the following:

37 a. A declaration that the approval is also deemed an amendment to the  
38 comprehensive plan. The governing board shall not require any  
39 additional request or application for amendment to the  
40 comprehensive plan.

41 b. An explanation of the change in conditions the governing board took  
42 into account in amending the zoning ordinance to meet the  
43 development needs of the community.

44 c. Why the action was reasonable and in the public interest.

45 (c) Prior to consideration by the governing board of the proposed zoning amendment,  
46 the planning board shall advise and comment on whether the proposed amendment is consistent  
47 with any comprehensive plan that has been adopted and any other officially adopted plan that is  
48 applicable. ~~plan.~~ The planning board shall provide a written recommendation to the governing  
49 board of county commissioners that addresses plan consistency and other matters as deemed  
50 appropriate by the planning board, but a comment by the planning board that a proposed

1 amendment is inconsistent with the comprehensive plan shall not preclude consideration or  
2 approval of the proposed amendment by the governing board.

3 (d) Zoning regulations shall be designed to promote the public health, safety, and  
4 general welfare. To that end, the regulations may address, among other things, the following  
5 public purposes: to provide adequate light and air; to prevent the overcrowding of land; to  
6 avoid undue concentration of population; to lessen congestion in the streets; to secure safety  
7 from fire, panic, and dangers; and to facilitate the efficient and adequate provision of  
8 transportation, water, sewerage, schools, parks, and other public requirements. The regulations  
9 shall be made with reasonable consideration as to, among other things, the character of the  
10 district and its peculiar suitability for particular uses, and with a view to conserving the value of  
11 buildings and encouraging the most appropriate use of land throughout the county. In addition,  
12 the regulations shall be made with reasonable consideration to expansion and development of  
13 any cities within the county, so as to provide for their orderly growth and development.

14 (e) As used in this section, "comprehensive plan" includes a unified development  
15 ordinance and any other officially adopted plan that is applicable."

16 **SECTION 2.4.(b)** G.S. 153A-349.13 reads as rewritten:

17 "**§ 153A-349.13. Relationship of agreement to building or housing ~~code~~ code;**  
18 **comprehensive plan amendment.**

19 (a) A development agreement adopted pursuant to this Chapter shall not exempt the  
20 property owner or developer from compliance with the State Building Code or State or local  
21 housing codes that are not part of the local government's planning, zoning, or subdivision  
22 regulations.

23 (b) When the governing board approves the rezoning of any property associated with a  
24 development agreement adopted pursuant to this Chapter, the provisions of G.S. 153A-341  
25 apply."

26 **SECTION 2.4.(c)** G.S. 160A-383 reads as rewritten:

27 "**§ 160A-383. Purposes in view.**

28 (a) Zoning regulations shall be made in accordance with a comprehensive plan. ~~When~~

29 (b) Prior to adopting or rejecting any zoning amendment, the governing board shall also  
30 approve a statement adopt one of the following statements which shall not be subject to judicial  
31 review:

32 (1) A statement approving the zoning amendment and describing whether its  
33 action is consistent its consistency with an adopted comprehensive plan and  
34 any other officially adopted plan that is applicable, and briefly explaining  
35 why the board considers the action taken to be is reasonable and in the

24           by the agency to determine any of the following:

48 confidential by law. An announcement that a business or industrial project has committed to  
49 expand or locate in the State shall not require disclosure of local government records relating to  
50 the project if the business has not selected a specific location within the State for the project.

 12 of the sanitary landfill in tons, a description of environmental  
 13 controls, and a description of any other waste management activities  
 14 to be conducted at the facility. In addition, the facility plan shall  
 15 show the proposed location of soil borrow areas, leachate facilities,  
 16 and all other facilities and infrastructure, including ingress and egress  
 17 to the facility.

- 18 (3) Prior to the award of a franchise for the construction or operation of a  
 19 sanitary landfill, the board of commissioners of the county or counties in  
 20 which the sanitary landfill is proposed to be located or is located or, if the  
 21 sanitary landfill is proposed to be located or is located in a city, the  
 22 governing board of the city shall conduct a public hearing. The board of  
 23 commissioners of the county or counties in which the sanitary landfill is  
 24 proposed to be located or is located or, if the sanitary landfill is proposed to  
 25 be located or is located in a city, the governing board of the city shall  
 26 provide at least 30 days' notice to the public of the public hearing. The notice  
 27 shall include a summary of all the information required to be included in the  
 28 franchise, and shall specify the procedure to be followed at the public  
 29 hearing. The applicant for the franchise shall provide a copy of the  
 30 application for the franchise that includes all of the information required to  
 31 be included in the franchise, to the public library closest to the proposed  
 32 sanitary landfill site to be made available for inspection and copying by the  
 33 public.

34 ...."

35 **SECTION 3.2.(c)** G.S. 160A-319(a) reads as rewritten:

36 "**§ 160A-319. Utility franchises.**

37 (a) A city shall have authority to grant upon reasonable terms franchises for a telephone  
 38 system and any of the enterprises listed in G.S. 160A-311, except a cable television system. A  
 39 franchise granted by a city authorizes the operation of the franchised activity within the city.  
 40 No franchise shall be granted for a period of more than 60 years, ~~except including a franchise~~  
 41 granted to a sanitary landfill for the life-of-site of the landfill pursuant to G.S. 130A-294(b1);  
 42 provided, however, that a franchise for solid waste collection or disposal systems and facilities  
 43 facilities, other than sanitary landfills, shall not be granted for a period of more than 30 years.

 45 franchise, a city may by ordinance make it unlawful to operate an enterprise without a  
 46 franchise."

49 (a) A county may by ordinance regulate the storage, collection, transportation, use,  
 50 disposal, and other disposition of solid wastes. Such an ordinance may:

 2 commercially collect or dispose of solid wastes within all or a defined  
 3 portion of the county and prohibit any other person from commercially

13 **SECTION 3.2.(e)** Subsection (a) of this section applies to franchise agreements (i)  
 14 executed on or after October 1, 2015, and (ii) executed on or before October 1, 2015, only if all  
 15 parties to a valid and operative agreement consent to modify the agreement for the purpose of  
 16 extending the agreement's duration of the life-of-site of the landfill for which the agreement  
 17 was executed, and public notice and hearing is provided for such modification in compliance  
 18 with the requirements of G.S. 130A-294(b1)(3).

19 **SECTION 3.3.** The Division of Waste Management of the Department of  
 20 Environmental Quality shall examine whether solid waste management activities in the State  
 21 are being conducted in a manner most beneficial to the citizens of the State in terms of  
 22 efficiency and cost-effectiveness, with a focus on solid waste disposal capacity across the State,  
 23 particularly areas of the State that have insufficient disposal capacity, as well as areas of the  
 24 State with disposal capacity that is underutilized, resulting in transport of waste to other  
 25 jurisdictions. The Department shall develop economic estimates of the short- and long-term  
 26 costs of waste transport in these situations versus full utilization of capacity, or expansion of  
 27 capacity, in the originating jurisdiction. The Department shall also provide information on  
 28 landfill capacity that is permitted but not yet constructed and expansion opportunities for future  
 29 landfill capacity. The Department shall submit a report, including any legislative  
 30 recommendations, to the Environmental Review Commission no later than May 1, 2017.

31 **SECTION 3.4.** Except as otherwise provided, Sections 3.1 and 3.2 of this act are  
 32 effective retroactively to July 1, 2015. Sections 3.3 and 3.4 of this act are effective when this  
 33 act becomes law.

 39 (2) Motor vehicle emissions inspections shall be performed by a person who  
 40 holds an emissions inspection mechanic license issued as provided in  
 41 G.S. 20-183.4A(c) at a station that holds an emissions inspection station  
 42 license issued under G.S. 20-183.4A(a) or at a place of business that holds  
 43 an emissions self-inspector license issued as provided in G.S. 20-183.4A(d).  
 44 Motor vehicle emissions inspections may be performed by a decentralized  
 45 network of test-and-repair stations as described in 40 Code of Federal  
 46 Regulations § 51.353 (1 July 1998 Edition). The Commission may not  
 47 require that motor vehicle emissions inspections be performed by a network  
 48 of centralized or decentralized test-only stations.

49 (b) Repealed by Session Laws 2000-134, s. 2, effective July 14, 2000.

1 (c) Counties Covered. – Motor vehicle emissions inspections shall be performed in the

 12 except for motor vehicles operated on a federal installation as provided in  
 13 sub-subdivision e. of subdivision (5) of this subsection.
- 14 (2) It is not a trailer whose gross weight is less than 4,000 pounds, a house  
 15 trailer, or a motorcycle.
- 16 (3) It is (i) a 1996 or later model vehicle with a model year within 20 years of  
 17 the current year and older than the three most recent model years or (ii) a

 24 amendment based on the change to the motor vehicle emissions testing program provided in  
 25 this section.

26 **SECTION 3.5.(d)** Subsections (a) and (b) of this section become effective on the  
 27 later of the following dates and apply to motor vehicles inspected, or due to be inspected, on or  
 28 after that effective date:

- 29 (1) October 1, 2017.
- 30 (2) The first day of a month that is 60 days after the Secretary of the Department  
 31 of Environmental Quality certifies to the Revisor of Statutes that the United  
 32 States Environmental Protection Agency has approved an amendment to the  
 33 North Carolina State Implementation Plan submitted as required by  
 34 subsection (c) of this section. The Secretary shall provide this notice along  
 35 with the effective date of this act on its Web site and by written or electronic  
 36 notice to emissions inspection mechanic license holders, emissions  
 37 inspection station licensees, and self-inspector licensees in the counties  
 38 where motor vehicle emissions inspection requirements are removed by this  
 39 section.

## 41 FARRIERS/HORSESHOEING

42 **SECTION 3.6.** G.S. 90-187.10 is amended by adding a new subdivision to read:

#### 34 **PROHIBIT CERTAIN STORMWATER CONTROL MEASURES**

35 **SECTION 3.11.(a)** Until the effective date of the revised permanent rule that the  
36 Environmental Management Commission is required to adopt pursuant to subsection (c) of this  
37 section, the Commission and the Department of Environmental Quality shall implement 15A  
38 NCAC 02H .0506 (Review of Applications) as provided in subsection (b) of this section.

39 **SECTION 3.11.(b)** Notwithstanding 15A NCAC 02H .0506(b)(5) and 15A NCAC  
40 02H .0506(c)(5), the Director of the Division of Water Resources shall not require the use of  
41 on-site stormwater control measures to protect downstream water quality standards, except as  
42 required by State or federal law.

43 **SECTION 3.11.(c)** The Environmental Management Commission shall adopt rules  
44 to amend 15A NCAC 02H .0506 (Review of Applications) consistent with subsection (b) of

8           "(b2) For purposes of implementing stormwater programs, "built-upon area" means  
9 impervious surface and partially impervious surface to the extent that the partially impervious  
10 surface does not allow water to infiltrate through the surface and into the subsoil. "Built-upon  
11 area" does not include a slatted deck; the water area of a swimming pool; a surface of number  
12 57 stone, as designated by the American Society for Testing and Materials, laid at least four  
13 inches thick over a geotextile fabric; ~~or~~ a trail as defined in G.S. 113A-85 that is either unpaved  
14 or paved as long as the pavement is porous with a hydraulic conductivity greater than 0.001  
15 centimeters per second (1.41 inches per ~~hour~~ hour); or landscaping material, including, but not  
16 limited to, gravel, mulch, sand, and vegetation, placed on areas that receive pedestrian or  
17 bicycle traffic or on portions of driveways and parking areas that will not be compacted by the  
18 weight of a vehicle, such as the area between sections of pavement that support the weight of a  
19 vehicle. The owner or developer of a property may opt out of any of the exemptions from  
20 "built-upon area" set out in this subsection. For State stormwater programs and local  
21 stormwater programs approved pursuant to subsection (d) of this section, all of the following  
22 shall apply:

- 23           (1) The volume, velocity, and discharge rates of water associated with the  
24 one-year, 24-hour storm and the difference in stormwater runoff from the  
25 predevelopment and postdevelopment conditions for the one-year, 24-hour  
26 storm shall be calculated using any acceptable engineering hydrologic and  
27 hydraulic methods.
- 28           (2) Development may occur within the area that would otherwise be required to  
29 be placed within a vegetative buffer required by the Commission pursuant to  
30 G.S. 143-214.1 and G.S. 143-214.7 to protect classified shellfish waters,  
31 outstanding resource waters, and high-quality waters provided the  
32 stormwater runoff from the development is collected and treated from the  
33 entire impervious area and discharged so that it passes through the  
34 vegetative buffer and is managed so that it otherwise complies with all  
35 applicable State and federal stormwater management requirements.
- 36           (3) The requirements that apply to development activities within one-half mile  
37 of and draining to Class SA waters or within one-half mile of Class SA  
38 waters and draining to unnamed freshwater tributaries shall not apply to  
39 development activities and associated stormwater discharges that do not  
40 occur within one-half mile of and draining to Class SA waters or are not  
41 within one-half mile of Class SA waters and draining to unnamed freshwater  
42 tributaries."  
43

## 44 **AMEND STREAM MITIGATION REQUIREMENTS**

45           **SECTION 3.13.(a)** G.S. 143-214.7C reads as rewritten:

46 **"§ 143-214.7C. Prohibit the requirement of mitigation for impacts to intermittent**  
47 **streams; streams; establish threshold for mitigation of impacts to streams.**

48           (a) Except as required by federal law, the Department of Environmental Quality shall  
49 not require mitigation for impacts to an intermittent stream. For purposes of this section,  
50 "intermittent stream" means a well-defined channel that has all of the following characteristics:

- 1 (1) It contains water for only part of the year, typically during winter and spring
- 2 when the aquatic bed is below the water table.
- 3 (2) The flow of water in the intermittent stream may be heavily supplemented
- 4 by stormwater runoff.
- 5 (3) It often lacks the biological and hydrological characteristics commonly
- 6 associated with the conveyance of water.

7 (b) Except as required by federal law, the Department of Environmental Quality shall  
8 not require mitigation for losses of 300 linear feet or less of stream bed."

9 **SECTION 3.13.(b)** The Environmental Management Commission shall amend its  
10 rules consistent with subsection (a) of this section.

11 **SECTION 3.13.(c)** The cochairs of the Environmental Review Commission shall  
12 examine the mitigation thresholds for losses of stream bed under the Regional Conditions  
13 adopted by the Norfolk, Charleston, and Savannah Districts of the United States Army Corps of  
14 Engineers and shall submit written comments to the Washington, D.C., Headquarters, the  
15 Wilmington District Office of the United States Army Corps of Engineers, and the North  
16 Carolina congressional delegation to encourage the Wilmington District to adopt Regional  
17 Conditions on the thresholds for losses of stream bed that are consistent with the Regional  
18 Conditions adopted by the Norfolk, Charleston, and Savannah Districts of the United States  
19 Army Corps of Engineers.

23 **SECTION 3.14.(a)** Sections 14.6(p) and 14.6(q) of S.L. 2015-241 are repealed.

25 Commission may adopt an emergency rule for the use of temporary erosion control structures  
26 consistent with the amendments to the temporary erosion control structure rules adopted by the

28 the Commission's discretion. The Commission shall also adopt temporary and permanent rules  
29 to implement this section.

34 07H .0312 (Technical Standards for Beach Fill Projects) for purposes of this section and its  
35 implementation.

36 **SECTION 3.15.(b)** Sediment Criteria Rule. – Until the effective date of the revised  
37 permanent rule that the Coastal Resources Commission is required to adopt pursuant to  
38 subsection (d) of this section, the Commission and the Department of Environmental Quality  
39 shall implement the Sediment Criteria Rule, as provided in subsection (c) of this section.

40 **SECTION 3.15.(c)** Implementation. – The Commission shall exempt from the  
41 permitting requirements of the Sediment Criteria Rule any sediment in the cape shoal systems  
42 used as a borrow site and any portion of an oceanfront beach that receives sediment from the  
43 cape shoal systems. For purposes of this section, "cape shoal systems" includes the Frying Pan  
44 Shoals at Cape Fear, Lookout Shoals at Cape Lookout, and Diamond Shoals at Cape Hatteras.

45 **SECTION 3.15.(d)** Additional Rule-Making Authority. – The Commission shall  
46 adopt a rule to amend the Sediment Criteria Rule consistent with subsection (c) of this section.  
47 Notwithstanding G.S. 150B-19(4), the rule adopted by the Commission, pursuant to this

49 adopted pursuant to this section are not subject to Part 3 of Article 2A of Chapter 150B of the  
50 General Statutes. Rules adopted pursuant to this section shall become effective as provided in

3 **SECTION 3.15.(e)** Sunset. – This section expires when permanent rules adopted as  
4 required by subsection (d) of this section become effective.

## 6 **DIVISION OF COASTAL MANAGEMENT TO STUDY CURRENT LONG-TERM** 7 **EROSION RATES ADJACENT TO TERMINAL GROINS**

8 **SECTION 3.16.** The Division of Coastal Management of the Department of  
9 Environmental Quality, in consultation with the Coastal Resources Commission, shall study the  
10 change in erosion rates directly adjacent to existing and newly constructed terminal groins to  
11 determine whether long-term erosion rates, currently in effect in accordance with 15A NCAC  
12 07H .0304 (AECS Within Ocean Hazard Areas), should be adjusted to reflect any mitigation of  
13 shoreline erosion resulting from the installation of the terminal groins. The Division shall report  
14 on the results of the study to the Environmental Review Commission on or before March 1,  
15 2018.  
16

## 17 **REGULATION AND DISPOSITION OF CERTAIN REPTILES**

18 **SECTION 3.17.(a)** G.S. 14-419 reads as rewritten:

19 **"§ 14-419. Investigation of suspected violations; seizure and examination of reptiles;**  
20 **disposition of reptiles.**

21 (a) In any case in which any law-enforcement officer or animal control officer has  
22 probable cause to believe that any of the provisions of this Article have been or are about to be  
23 violated, it shall be the duty of the officer and the officer is authorized, empowered, and  
24 directed to immediately investigate the violation or impending violation and to consult with  
25 representatives of the North Carolina Museum of Natural Sciences or the North Carolina  
26 Zoological Park or a designated representative of either the Museum or Zoological Park to  
27 identify appropriate and safe methods to seize the reptile or reptiles involved, to seize the  
28 reptile or reptiles involved, and the officer is authorized and directed to deliver: (i) a reptile  
29 believed to be venomous to the North Carolina State Museum of Natural Sciences or to its  
30 designated representative for examination for the purpose of ascertaining whether the reptile is  
31 regulated under this Article; and, (ii) a reptile believed to be a large constricting snake or  
32 crocodilian to the North Carolina Zoological Park or to its designated representative for the  
33 purpose of ascertaining whether the reptile is regulated under this Article. In any case in which  
34 a law enforcement officer or animal control officer determines that there is an immediate risk to  
35 public safety, the officer shall not be required to consult with representatives of the North  
36 Carolina Museum of Natural Sciences or the North Carolina Zoological Park as provided by  
37 ~~this subsection~~ subsection and may kill the reptile.

38 (b) If the Museum or the Zoological Park or their designated representatives find that a  
39 seized reptile is a venomous reptile, large constricting snake, or crocodilian regulated under this  
40 Article, the Museum or the Zoological Park or their designated representative shall determine  
41 ~~final-an interim~~ disposition of the reptile in a manner consistent with the safety of the public,  
42 ~~which in-until a final disposition is determined by a court of competent jurisdiction.~~ In the case  
43 of a venomous reptile for which antivenin approved by the United States Food and Drug  
44 Administration is not readily available, shall the reptile may be euthanized unless the species is  
45 protected under the federal Endangered Species Act of 1973. Where the Museum or the  
46 Zoological Park or their designated representative determines euthanasia to be the appropriate  
47 interim disposition, or where a reptile seized pursuant to this Article dies of natural or  
48 unintended causes, the Museum, the Zoological Park, or their designated representatives shall  
49 not be liable to the reptile's owner.

50 (b1) Upon conviction of any offense contained in this Article, the court shall order a final  
51 disposition of the confiscated venomous reptiles, large constricting snakes, or crocodilians,

1 which may include the transfer of title to the State of North Carolina and reimbursement for the  
2 necessary expenses incurred in the seizure, delivery, and storage thereof.

3 (c) If the Museum or the Zoological Park or their designated representatives find that  
4 the reptile is not a venomous reptile, large constricting snake, or crocodylian regulated under  
5 this Article, and either no criminal warrants or indictments are initiated in connection with the  
6 reptile within 10 days of initial seizure, or a court of law determines that the reptile is not being  
7 owned, possessed, used, transported, or trafficked in violation of this Article, then it shall be the  
8 duty of the law enforcement officer to return the reptile or reptiles to the person from whom  
9 they were seized within 15 days."

15 economic interest in preserving, maintaining, and sustaining land uses that are compatible with  
16 military activities at major military installations and National Guard facilities. In its work, the  
17 Committee shall develop and implement programs and strategies that (i) protect working lands  
18 in the vicinity of and where testing and training occur near or adjacent to major military  
19 installations or other areas of strategic benefit to national defense, (ii) address restrictions that  
20 inhibit military testing and training, and (iii) forestall incompatible development in the vicinity  
21 of and where testing and training occur near or adjacent to military installations or other areas  
22 of strategic benefit to national defense.

23           **SECTION 3.19.(c)** Powers and Duties. – The Committee shall:

- 24           (1) Recognize all lands in the State as sentinel landscapes areas that are so  
25 designated by the United States Department of Defense.
- 26           (2) Identify and designate certain additional lands to be contained in the sentinel  
27 landscapes of this State that are of particular import to the nation's defense  
28 and in the vicinity of and where testing and training occur on, near, or  
29 adjacent to major military installations or are of other strategic benefit to the  
30 nation's defense. In this work, the Committee may seek advice and  
31 recommendations from stakeholders who have experience in this sort of  
32 identification and designation.
- 33           (3) In designating sentinel lands as directed by subdivision (1) of this  
34 subsection, the Committee shall evaluate all working or natural lands that the  
35 Committee identifies as contributing to the long-term sustainability of the  
36 military missions conducted in this State. In its evaluation of which lands to  
37 designate as sentinel lands, the Committee shall consult with and seek input  
38 from:
- 39           a. The United States Department of Defense.  
40           b. The North Carolina Commander's Council.  
41           c. The United States Department of Agriculture.  
42           d. The United States Department of the Interior.  
43           e. Elected officials from units of local government located in the  
44 vicinity of and where testing and training occur on the proposed  
45 sentinel lands.  
46           f. Any other stakeholders that the Committee deems appropriate.
- 47           (4) Develop recommendations to encourage landowners located within the  
48 sentinel landscape designated pursuant to subdivision (1) of this subsection  
49 to voluntarily participate in and begin or continue land uses compatible with  
50 the United States Department of Defense operations in this State.



- 1 (5) Provide technical support services and assistance to landowners who  
2 voluntarily participate in the sentinel landscape program.

3 **SECTION 3.19.(d) Membership.** – The Committee shall consist of at least the five  
4 following members:

- 5 (1) The Commissioner of Agriculture, or the Commissioner's designee.  
6 (2) The Secretary of the Department of Military and Veterans Affairs, or the

9 (4) The Executive Director of the Wildlife Resources Commission, or the
