6 The General Assembly of North Carolina enacts:

8 **PART I. PRESIDENT PRO TEMPORE'S RECOMMENDATIONS**

9 **SECTION 1.1.** Effective January 1, 2021, Brian T. Drew of Wake County is
10 appointed to the 911 Board for a term expiring on December 31, 2024.

11 **SECTION 1.2.** Walter D. Giese of Onslow County is appointed to the North Carolina
12 Board for Licensing of Soil Scientists for a term expiring on June 30, 2023.

13 **SECTION 1.3.** Brooke L. Child of Davidson County is appointed to the North
14 Carolina Child Care Commission for a term expiring on June 30, 2022.

15 **SECTION 1.4.** Lauren T. Pruett of Davidson County is appointed to the North
16 Carolina Interpreter and Transliterator Licensing Board for a term expiring on June 30, 2023.

17 **SECTION 1.5.** Effective October 1, 2020, Jonathan H. Freeman of Forsyth County
18 and Peter C. Milner of Wake County are appointed to the North Carolina State Board of
19 Examiners of Fee-Based Practicing Pastoral Counselors for terms expiring on September 30,
20 2024.

21 **SECTION 1.6.** Travis K. Morehead of Stanly County is appointed to the North
22 Carolina Mining Commission for a term expiring on December 31, 2022.

23 **SECTION 1.7.** Catherine B. Mitchell of Buncombe County is appointed to the North
24 Carolina School of Science and Mathematics Board of Trustees for a term expiring on June 30,
25 2021.

27 **PART II. CORRECTIONS**

28 **SECTION 2.1.** Section 2.24 of S.L. 2020-39 reads as rewritten:

29 "SECTION 2.24. Effective July 1, 2020, the Honorable William Brawley of Mecklenburg
30 County is appointed to the North Carolina Medical Board for a term expiring on ~~June 30,~~
31 ~~2023.~~October 31, 2023."

32 **SECTION 2.2.** Section 2.33 of S.L. 2020-39 reads as rewritten:

33 "SECTION 2.33. Effective July 1, 2020, Thomas R. Lawing, Jr., of Mecklenburg County is
34 appointed to the North Carolina Real Estate Commission for a term expiring on ~~June 30,~~
35 ~~2023.~~July 31, 2023."
