AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES
AND THE PRESIDENT PRO TEMPORE OF THE SENATE AND TO MAKE
CORRECTIONS TO PREVIOUS APPOINTMENTS.

The General Assembly of North Carolina enacts:

PART I. SPEAKER'S RECOMMENDATIONS
