A BILL TO BE ENTITLED

AN ACT TO PROTECT AND RESTORE WETLANDS IN NORTH CAROLINA.

3 The General Assembly of North Carolina enacts:

5 **PART I. FUNDING**

6 SECTION 1.(a) Establishment and Purpose of Fund. – The sum of fifteen million 7 dollars (\$15,000,000) in recurring funds for the 2024-2025 fiscal year is appropriated from the 8 General Fund to the Department of Environmental Quality. Funds appropriated by this section 9 shall be used by the Department to establish the Wetlands Restoration and Protection Fund 10 (Fund) as a special fund in the Department. The Fund consists of appropriations by the General 11 Assembly as well as contributions and grants from public or private sources. The purpose of the Fund is to provide financial support for (i) wetland restoration projects, (ii) acquisition of 12 13 conservation easements, (iii) public awareness campaigns to educate citizens about the 14 importance of wetlands and the need for their protection and opportunities for volunteer wetlands protection and restoration projects, through the Department's Office of Environmental Education 15 and Public Affairs, and (iv) enforcement of wetland protection laws as amended by Section 2 of 16 17 this act to restore protection of certain wetlands in the State that were removed from federal protection under the Clean Water Act by the United States Supreme Court ruling in Sackett v. 18 19 EPA, 598 U.S. 651 (2023).

20 **SECTION 1.(b)** Reservation of Funds for Monitoring and Research. – Five million 21 dollars (\$5,000,000) of the funds appropriated by subsection (a) of this section is designated for 22 wetland monitoring and research initiatives. The Department, in collaboration with relevant 23 stakeholders and research institutions, will conduct comprehensive monitoring and research to 24 assess the health and ecological value of wetlands throughout the State.

SECTION 1.(c) Report. - The Department shall submit a report no later than 25 26 September 1, 2025, and annually thereafter to the Joint Legislative Oversight Committee on Agriculture and Natural and Economic Resources and the Fiscal Research Division on the 27 projects and activities funded by this act during the prior fiscal year. The Department shall 28 29 include in its initial report and may include in subsequent reports recommendations regarding 30 further legislative changes needed to provide comprehensive protection for isolated wetlands at the State level in response to the Sackett decision. The reports shall also include, at a minimum, 31 32 the following:

(1)The beginning and ending balance of the Fund for the fiscal year.

- A listing of funding recipients, and the amount provided to each recipient. (2)

An overview of the use of funds by funding recipients, including a description (3) of projects constructed or planning milestones achieved.
