RE: Non-Revenue and Non-Appropriations Bills Crossover List - 2017

Attached is a list of bills meeting the April 27, 2017 "crossover" deadline. This is the date by which most bills must pass from one chamber to the other in order to be eligible for consideration for the remainder of this regular session. These bills have passed one chamber, been received by or ordered sent to the other chamber, and have not been defeated in the other chamber.

Click on the bill number in the list to view the current status on the General Assembly web page at www.ncleg.net.

House and Senate rules exempt several categories of bills from this deadline, such as appropriations, revenue and redistricting. This list does not include those bills, unless they passed from one chamber to the other by April 27. Any bill not on the attached list must be analyzed individually to determine if it is subject to the crossover deadline. This list also does not include ratified legislation as of April 27 which, if vetoed, would be constitutionally eligible for continued consideration. Legislation that passed one chamber by April 27 and is being engrossed complies with the crossover rule if a message to that effect is received in the other chamber by the next legislative day.

Following are the full crossover guidelines.

House Rules for Senate Bills:

A Senate bill or resolution not otherwise exempt must be received and read on the floor of the House as a message from the Senate no later than Thursday, April 27, 2017 in order to be eligible for consideration by the House during the rest of the 2017 first Regular Session. See House Rule 31.1 (h). (H. Res. 114).

The following legislation is exempt from this House crossover deadline (House Rules 31(h), 31(j)):

1. Adjournment resolutions (sine die or to a day certain).
2. Bills that must be re-referred to the House Appropriations or Finance committees under Rule 38; or
3. Bills introduced on the report of the Committees on Appropriations, Finance, or Rules, Calendar, and Operations of the House; or
4. Bills establishing districts for Congress or State or local entities; or
5. Bills that ratify an amendment or amendments to the U.S. Constitution.

Senate Rules for House Bills:

A House bill or resolution not otherwise exempt must be received and read on the floor of the Senate as a message from the House no later than Thursday, April 27, 2017 in order to be eligible for consideration by the Senate during the rest of the 2017 and 2018 Regular Sessions. See Senate Rule 41 (S. Res. 1, as amended by S. Res. 459 and S. Res. 676).

The following legislation is excepted from this Senate crossover deadline (Senate Rule 41):

1. Bills required to be referred to the Committee on Finance or the Committee on Appropriations/Base Budget by Rule 42; or
2. Bills establishing districts for Congress or State or local entities; or
3. Amendments to the North Carolina Constitution; or
4. Statutory amendments necessary to implement proposed amendments to the North Carolina Constitution; or
5. Bills ratifying an amendment or amendments to the Constitution of the United States; or
6. Adjournment resolutions.
